## Other Benefits

**Disability Income Benefit** – a \$70 per month benefit for adult beneficiaries with a disability who receive the Living Income benefit or the Modified Living benefit.

**Northern Living Supplement** - a monthly benefit may be provided to meet the additional costs of living in northern communities (\$50 per member of the family unit)

**Household Disability Support Benefit** - a \$25 per month benefit may be provided to enable an eligible beneficiary or member of the family unit to pay for household tasks that the beneficiary or member of the family unit is unable to perform because of a disability.

**Exceptional Needs Activity Benefit** – a \$25 per month benefit may be provided to an eligible beneficiary who resides in approved private-service homes licensed through The Mental Health Services Act or The Residential Services Act or in homes licensed through The Personal Care Homes Act.

**Personal Living Benefit -** a \$265 per month benefit may be provided for an adult beneficiary residing in a residential care facility, a hotel room where restaurant meals are required, a long-term residence that provides partial personal supports, a temporary residential facility or treatment centre, or other arrangements where the Living Income benefit is not provided. Children may receive \$55.
