1. Introduction

This Directive sets out the fees and related policies for sale of oil and gas data and related services by the Saskatchewan Ministry of the Economy (ECON). Persons interested in acquiring a data product or obtaining related services should contact the PNG Service Desk at 1-855-219-9373 or by email at PNG.Support@gov.sk.ca.

2. Governing Legislation

The Directive is governed by subsection 10(e) of *The Mineral Resources Act, 1985* which provides the authority for the Minister to “*prescribe the fees to be paid for any information or services and reports, maps and other documents made available by the department to the public*”.

3. Administration

Subscription pricing is based on annual subscriptions beginning in April and ending in March each year. Renewals will be effective April 1st.

Subscriptions will not be prorated. Subscriptions for part of a year are subject to monthly pricing.

Data products are subject to Provincial Sales Tax (PST) and the federal Goods and Services Tax (GST). Taxes are in addition to prices listed. Non-resident companies (e.g. out of province billing address) are required to self-assess PST.

Subscriptions will be delivered via email.

4. Terms of Use

All data products are subject to the terms of use (TOU) agreement in Appendix A.

The terms of use agreement will be included with every data product.

5. Exemption Policy

ECON reserves the right to waive fees.

6. Fee Schedule

Data products listed here are released at regular intervals (monthly or weekly). They can be purchased as annual subscriptions or as individual releases. Data products are classified as computer services and therefore subject to PST and GST. Taxes are in addition to the prices listed.¹

Appendix A: Terms of Use Agreement

The following agreement describes the terms under which oil and gas data products are provided by ECON for use by a Subscriber. By using the data, the Subscriber agrees to the terms and conditions set forth below.

This Product is made available under the following conditions.

For internal use: the Subscriber will only use the Product in the provision of its own services and will not reproduce, duplicate or copy the Product or distribute the Product to any third party without the prior written consent of the Saskatchewan Ministry of the Economy (ECON).

However, resale or redistribution is permitted where the subscriber demonstrates to ECON's satisfaction, when requested, that it is adding a quantifiable benefit or value to the Product/s following purchase from ECON (e.g. additions, deletions, formatting, analysis, etc.).

ECON retains all copyright, property and legal and beneficial ownership in the Product/s. No unauthorized commercial reproduction or exploitation is allowed. ECON makes no representation, warranty or guarantee, either expressed or implied, regarding the accuracy of the Product/s or its fitness for the intended use by the Subscriber. ECON is not responsible for any costs incurred by any party due to conversion, installations, or improvement of the Product/s. ECON reserves the right to discontinue the subscription, without notice and for any reason whatsoever, if, in ECON's sole opinion, the Subscriber does not comply with any of the above provisions.
