

SASKATCHEWAN IMMIGRANT NOMINEE PROGRAM (SINP)

One criterion for the SINP Entrepreneur category is verified legal accumulation of funds. By completing this form, signing and dating the declaration, and providing supporting documentation, you allow the SINP to assess your eligibility under these criteria. This form is one of the documents that you must submit with your full application to the SINP Entrepreneur category. The completed form must be signed and dated.

Instructions

- Based on the table below, provide your work history and indicate the total gross income that you have received and the business, family investments, and loans that you made during a given work period, for each of the last ten years. The amounts must be indicated in the local currency. Please use as many copies of the supplied table as necessary to report your work history.
- Present the work periods chronologically, from the earliest to the most recent. Fill in a single table for each work period. A work period begins when you receive income (salary, dividends or other income) from a new enterprise. Fill out a separate table for each enterprise if you received or are receiving remuneration from more than one enterprise during a given period.
- In this guide, the term “enterprise” indicates the organization from which you receive remuneration, whether as an employee, an owner or a shareholder.
- The claimed assets and liabilities owned by the Applicant's spouse **must** be reported, as such your spouse must fill out a separate accumulation of funds form.
- The declaration must be signed and dated. It must not be modified under any circumstances.
