Users that subscribed to receive an email alert when new well and facility infrastructure notifications are available in IRIS are encouraged to review their notifications mailbox in the system.

A script that prompts IRIS to send an email to subscribers when new well and facility notifications are issued in the system is unavailable, and has been unavailable since February 2 when the new email alert subscription functionality was implemented. Although the notifications are available in IRIS, subscribers to the following notification types did not receive an email alert:

- Authorization Expiry Date Changed
- Authorization Revoked
- Detailed Incident Submission Due
- Reminder: Detailed Incident Submission Due

Reminder: These notifications are available in IRIS, and it is the responsibility of each Business Associate (BA) to monitor and act upon notifications as required, regardless of whether an email alert is sent to an individual user within the BA.

A fix for the email alert issue will be implemented on March 2, during IRIS's regular monthly maintenance. Once the fix is in place, email alerts will generate for notifications posted to IRIS as of midnight March2. In an effort to avoid confusion as well as cluttering user email boxes, old email alerts for notifications posted between February 2 and March 1 won't be sent.
