**CHAPTER 60**

An Act respecting The Baptist Union of Western Canada

(Assented to March 14, 1911)

**Preamble**

WHEREAS The Baptist Union of Western Canada, incorporated by the Legislative Assembly of the Province of Manitoba, by chapter 81, 9 Edward VII, and chapter 83, 10 Edward VII, has by its petition prayed that it be enacted as hereinafter set forth and it is expedient to grant the prayer of the said petition:

Therefore his Majesty by and with the advice and consent of the Legislative Assembly of Saskatchewan enacts as follows:

**Powers**

**1** The Baptist Union of Western Canada shall in Saskatchewan have the same rights, powers and liabilities as if it had been incorporated by Act of the Legislature of Saskatchewan in the terms of the hereinbefore recited Acts.

**Holding real estate, etc.**

**2** The Baptist Union of Western Canada shall in Saskatchewan have all the powers relating to the acquiring, disposing of and dealing with real estate in Saskatchewan which were granted to the aforesaid corporation in Manitoba by the hereinbefore recited Acts of the Legislative Assembly of Manitoba.

**Trustees of any Baptist church may convey real property, etc.**

**3** Notwithstanding any laws to the contrary but subject always to the provisions of *The Land Titles Act* the trustees of any real property of any Baptist church in Saskatchewan may by deed or transfer convey to The Baptist Union of Western Canada such church property held by them and such deed or transfer shall vest the property in The Baptist Union of Western Canada and shall be deemed sufficient for every purpose and all property so conveyed may be held sold, leased, mortgaged or in any other way dealt with by The Baptist Union of Western Canada in the same manner and to the same extent as such corporation might deal with any other real estate owned or held by it:

**Conveyance to be sanctioned by meeting of church**

Provided only that the giving of a deed or transfer by the trustees of any Baptist church to The Baptist Union of Western Canada shall first be directed or sanctioned by a duly called meeting of the said church the said meeting having been called for that purpose and in accordance with the constitution and bylaws of the church.

(2) Proof of all matters referred to in this section shall be statutory declaration to the satisfaction of the registrar of the land registration district in which any land so sought to be transferred or conveyed is situate.

**Transfer of assets, etc.**

4 All the assets, interests, rights, credits, effects and property (real, personal and mixed) of whatsoever kind and wheresoever situate belonging to The Baptist Convention of Manitoba and the North-West Territories or to which it was or may be or become entitled shall be as and from the date of the coming into force of this Act transferred to and vested in The Baptist Union of Western Canada, its successors and assigns, to its and their own use and benefit absolutely for all the estate, right, title, interest, claim, properties and demands which the said The Baptist Convention of Manitoba and the North-West Territories shall have or be entitled to have had at the said date or to which the said The Baptist Convention of Manitoba and the North-West Territories would thereafter have been or become entitled and the said The Baptist Union of Western Canada shall be and is hereby empowered to exercise in Saskatchewan all such powers, rights and privileges in relation to the said assets, interests, rights, credits, effects and property (real, personal and mixed) of whatsoever kind and wheresoever situate as The Baptist Convention of Manitoba and the North-West Territories had or might have had and no suit, action or proceeding being carried on or power or remedy being exercised shall be discontinued or abated by or on account of this Act but the same may be continued in the name of the original party to the proceeding, suit or action or exercising such powers or remedy and the said The Baptist Union of Western Canada shall have the same rights and remedies and be subject to the same liabilities, debts and duties and shall pay and receive the like costs as if the suits, actions or proceeding as had been commenced or defended or exercised in the name of the said The Baptist Union of Western Canada.

**Creditors not affected**

5 Nothing in this Act shall impair or affect the rights of any creditors of the said The Baptist Union of Western Canada or the said The Baptist Convention of Manitoba and the North-West Territories or of either of them.

**Returns to be made**

6 It shall be the duty of the said corporation at all times when they may be called upon by the Lieutenant Governor in Council of Saskatchewan to render an account in writing of its property in which shall be set forth in particular the income by them derived from property held in Saskatchewan and the source from which the same was received.

**Repeal**

7 All Acts, Ordinances and portions thereof inconsistent with the provisions of this Act are hereby repealed in so far as may be necessary to give full effect to the provisions of this Act.
