### CHAPTER 88

# An Act respecting The Town of Gravelbourg

(Assented to December 15, 1920)

### Preamble

WHEREAS the town of Gravelbourg has applied to the Local Government Board for permission to raise money by way of debenture to provide for the installation of a system of water works and sewers in the said town;

And whereas certain property within the town of Gravelbourg owned by the corporation known respectively as "La Corporation Episcopale Catholique Romaine de Regina," "Les Religieuses de Jesus-Marie of Gravelbourg" and "Le College Catholique de Gravelbourg," is by the respective acts of incorporation of the said corporations or by the provisions of *The Town Act*, exempt from taxation;

And whereas the Local Government Board has granted the said permission upon the condition, among others, that the said corporations agree to waive all exemption from taxation which they may by law enjoy, and to become subject to all assessments, taxes, rates and levies of every nature and kind made or imposed in connection with the installation, maintenance and operation of the said sewers and water works; and upon the further condition that such agreements between the corporations and the town of Gravelbourg be verified and confirmed by the Legislature of Saskatchewan;

And whereas the aforesaid agreements have been executed by each of the aforesaid corporations, and the town of Gravelbourg has by its petition prayed that such agreements be verified and confirmed in accordance with the aforesaid direction of the Local Government Board, and it is expedient to grant the prayer of the said petition:

Now therefore His Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

### Ratification of certain agreements

1 The three agreements all dated the twenty-ninth day of April, 1920, and on file in the office of the Local Government Board made between the town of Gravelbourg and each of the corporations known respectively as, "La Corporation Episcopale Catholique Romaine de Regina," "Les Religieuses de Jesus-Marie of Gravelbourg" and "Le College Catholique de Gravelbourg" are and each of them is hereby approved, ratified and confirmed and declared to be and to have been at all times legal and valid, and binding upon each of the said corporations; and notwithstanding the exemptions from taxation granted by the special Acts of incorporation of the said corporations or by The Town Act, all the property of each of the said corporations, their and each of their successors and assigns, in the said town of Gravelbourg is hereby declared to be and to have been at all times since the aforesaid twenty-ninth day of April, 1920, liable to all assessments and for the payment of all taxes, rates and levies made or raised or which may hereafter be made or raised, in connection with the installation, maintenance and operation of the system of water works and sewers referred to in the recital to this Act, whether such assessments, taxes, rates or levies are made or imposed or may hereafter be made or imposed as special frontage assessment taxes or otherwise howsoever.
