CHAPTER 76

An Act to incorporate the Mantle Memorial Scholarship Fund Trustees

(Assented to January 28, 1926)

Preamble

WHEREAS a committee consisting of the Honourable Charles M. Hamilton, Professor William J. Rutherford, John A. Maharg, Nathaniel B. Williams, Alexander J. MacPhail, Olaf Olafson, Percy E. Reed, John G. Robertson and Francis H. Auld have undertaken to procure subscriptions for the establishment of a memorial in honour of the name, and to perpetuate the memory of, the late Major Alfred Frank Mantle, a distinguished citizen who efficiently served the Province of Saskatchewan for several years as Deputy Minister of Agriculture and during the Great War yielded up his life near Courcellette, in France, on September 26, 1916, at the age of thirty-four years; and

Whereas the committee has, by resolution, recommended that a scholarship be established in the University of Saskatchewan to encourage the education of farmers' sons and to be known as "The Mantle Memorial Scholarship," and that administration of the moneys collected or subscribed for the purpose be placed in the hands of trustees; and

Whereas the committee has by its petition prayed that trustees be named and such trustees incorporated, and it is expedient to grant the prayer of the said petition:

Now, therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Trustees incorporated

1 The persons now and from time to time hereafter filling the offices of Minister of Agriculture of Saskatchewan, Dean of the College of Agriculture of the University of Saskatchewan and President of the Agricultural Societies of Saskatchewan are hereby constituted a body corporate under the name of "The Mantle Memorial Scholarship Fund Trustees," with power to collect and receive moneys and accept gifts to be used in creating a fund for the establishment of a scholarship in the University of Saskatchewan to encourage the education of farmers' sons and to be known as "The Mantle Memorial Scholarship," and with power to administer the said fund.

Investment

2 The corporation may from time to time invest the moneys in their hands in any class of securities in which trustees are allowed by law to invest trust funds.

Regulations

3 The corporation may make regulations for determining the nature and amount of the scholarship, the conditions on which, and the manner in which, it shall be awarded, and all other matters necessary or desirable for carrying out the objects of the fund.

Report

4 The corporation shall report annually regarding the fund at the annual convention of the Agricultural Societies of Saskatchewan, presenting a statement of the amount of money received, how such money is invested, the revenue earned therefrom during the preceding calendar year, and the disbursements made therefrom, together with a list of persons to whom the scholarship has been awarded during the year.
