CHAPTER 106

An Act dealing with Certain Bylaws of the City of Moose Jaw

(Assented to March 27, 1930)

Preamble

WHEREAS the City of Moose Jaw issued and sold debentures pursuant to bylaws 782/1064 and 783/1064 for the sum of Thirty thousand (\$30,000.00) dollars, for the purpose of extending sewer and water connections to the subdivision known as Wellesley Park; and

Whereas the said debentures were issued to enable the City to carry out its part of a contract with the Wellesley Securities Corporation Limited and certain guarantors of the latter whereby the said Wellesley Securities Corporation Limited was to erect houses in the said subdivision, the City on its part agreeing to extend the sewer and water connections thereto; and

Whereas the said Corporation became financially unable to carry out its contract and by mutual consent and agreement between the City and the Corporation, the said contract was cancelled and the City was thereby released from any obligation to construct the said sewer and water mains for which the debentures had already been issued and sold; and

Whereas the City has continued to make regular levies provided by bylaw to meet the payments maturing under the said debentures so issued as aforesaid; and

Whereas the city of Moose Jaw issued debentures under and pursuant to the various referred or public utilities bylaws hereinafter recited; and

Whereas due to various causes it became necessary to pay out of current account additional sums to complete the work provided in the various bylaws immediately heretofore referred to in all in the sum of \$30,172.92, and the City desires appropriated the unused proceeds of the bylaws 782/1064 and 783/1064 to recoup the City for such over-expenditures and it is expedient to grant the prayer of the said petition:

Appropriations ratified

Now Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Power to appropriate

1 The City of Moose Jaw is hereby authorised to appropriate the proceeds of the said debentures for sewer and water connections to Wellesley Park for the purpose of paying off, insofar as the same extend, the excess of the actual cost, as hereinafter set out, over the amount provided for in the following bylaws, namely:
