## CHAPTER 2

### An Act respecting the Legislative Assembly

#### SHORT TITLE

##### Short title

**1** This Act may be cited as *The Legislative Assembly Act*.

#### COMPOSITION AND DURATION OF ASSEMBLY

##### Composition of Legislative Assembly

**2** The Legislative Assembly shall be composed of fifty-nine members to be elected to represent the electoral divisions defined in schedule 1 to this Act until the Legislature otherwise provides.

##### Duration

**3** Every Legislative Assembly shall continue, for five years from the date of the return of the writs for the election and no longer, but the Lieutenant Governor may at any time dissolve the Assembly and cause a new one to be chosen.

##### Session once a year

**4** There shall be a session of the Legislature at least once in every year, so that twelve months shall not intervene between the last sitting of the Assembly in one session and its first sitting in the next.

##### Not determined or dissolved by demise of the Crown

**5** No Legislative Assembly in and for the Province of Saskatchewan shall determine or be dissolved by the demise of the Crown, but the same shall continue and may meet, convene, sit, proceed and act notwithstanding such demise of the Crown in the same manner as if such demise had not happened.

**Power of Crown to prorogue or dissolve not affected**

**6** Nothing in section 5 shall alter or abridge the power of the Crown to prorogue or dissolve the Legislative Assembly.

**Quorum in Assembly**

**7** The quorum required for the transaction of business in the Legislative Assembly shall be fifteen of whom the Speaker may be one.

**QUALIFICATIONS OF MEMBERS****Who eligible for Assembly**

**8** Any British subject by birth or naturalisation whether male or female, of the full age of twenty-one years, resident in Saskatchewan, shall be eligible for nomination and election as a member of the Legislative Assembly unless disqualified under this or any other Act.

**Oath of members**

**9** Every member of the Legislative Assembly, before taking his seat therein, shall take and subscribe before the Lieutenant Governor or before such person as is designated by him the following oath:

“I, \_\_\_\_\_ A. B., do swear that I will be faithful and bear true allegiance to His Majesty, his heirs and successors.”

**Senators and members of Parliament ineligible**

**10** No senator or member of the House of Commons of Canada shall be eligible for election as a member of the Legislative Assembly.

**Holders of certain offices disqualified**

**11** No person except the members of the Executive Council for the Province of Saskatchewan and except coroners and justices of the peace, who shall hold any office or place of profit under the Government or who shall be in any manner employed in the public service of the province for salary, wages, fees or emolument, shall sit or vote in the Legislative Assembly, and the election of any such person to be a member of the Legislative Assembly shall be null and void, but nothing in this section shall be construed to apply to the Speaker or Deputy Speaker of the Legislative Assembly.

**Acceptance of membership in Executive Council voids election**

**12(1)** If any member of the Legislative Assembly becomes a member of the Executive Council his election shall thereby become void and his seat shall be vacated, and a writ shall issue for a new election in the manner provided by section 43 of this Act, but he shall be eligible for re-election if not otherwise declared ineligible under this Act.

(2) Nevertheless when a member of the Legislative Assembly, being a member of the Executive Council for the Province of Saskatchewan and holding one of the offices which may be held by such members under the provisions of *The Executive Council Act*, resigns his office and within one month after his resignation accepts another of the said offices, he shall not thereby vacate his seat in the Legislative Assembly unless the administration of which he was a member has resigned and a new administration occupies the said offices; and in case a member of the Executive Council holding any one of the said offices is appointed to hold another office in addition to or in connection with such first mentioned office he shall not thereby vacate his seat in the Legislative Assembly.

(3) Nothing herein contained shall be held to vacate the seat in the Legislative Assembly of a member who becomes a member of the Executive Council without portfolio, and the payment to such member of \$12 per day for each day on which he attends a meeting of the Executive Council together with payment of the travelling expenses and disbursements incurred by him in attendance at such meetings shall not affect his right to sit and vote in the Legislative Assembly.

**Persons interested in contract with government or in profits thereof ineligible**

**13(1)** No person who shall either directly or indirectly be concerned or interested in any bargain or contract entered into by or on behalf of the Government, or who shall participate or claim to be entitled to participate either directly or indirectly in the profit thereof or in any benefit or emolument arising from the same, shall sit or vote in the Legislative Assembly, and the election of such person to be a member of the Legislative Assembly shall be absolutely null and void.

(2) No member of the assembly shall obtain a loan from the Saskatchewan Farm Loan Board, but in case any person has obtained a loan from the board when not a member of the assembly, such loan shall not disqualify him from being subsequently elected as a member thereof or from sitting and voting therein.

**Other acts vacating seat of member**

**14** If any member of the Legislative Assembly shall either directly or indirectly become concerned or interested in any bargain or contract entered into by or on behalf of the Government, or shall participate or claim to be entitled to participate whether directly or indirectly in the profit thereof or in any benefit or emolument arising from the same, or shall accept any office or place of emolument under the Government, or shall in any character or capacity for or in expectation of any fee, gain or reward perform any duty, transact any business or do anything whatsoever for or on behalf of the Government, his seat shall thereupon be vacant.

**Shareholder or director of incorporated company having contract with government not disqualified**

**15(1)** Nothing contained in this Act shall extend to or disqualify any person as a member of the Legislative Assembly by reason of his being a shareholder or director of any incorporated company having a contract or agreement with the Government of Saskatchewan except any company which undertakes a contract for the building of any public work, nor shall anything contained in this Act extend to or disqualify any member of the Legislative Assembly who being a regularly qualified member of the medical profession performs services and receives fees therefor under the provisions of *The Dangerous Lunatics Act*; nor shall anything contained in this Act extend to or disqualify any member of the Legislative Assembly by reason only of such member becoming a party either as principal or surety to a bond given to His Majesty under the provisions of *The Succession Duty Act*, or by reason of his purchasing or becoming the holder of the stock, bonds or government securities of Saskatchewan on terms common to all persons.

(2) Nothing contained in this Act shall extend to or disqualify any person as a member of the Legislative Assembly by reason of his entering into a contract with the Government of the province or a department thereof for the supply or sale to such person of any utility or article of merchandise administered or sold by such Government or department.

**Ineligible person not to sit or vote**

**16(1)** No person declared by this Act or by any other law ineligible as a member of the Legislative Assembly shall sit or vote therein while under such disability.

**Penalty**

(2) If any such person sits or votes in the Legislative Assembly he shall be liable to a penalty of \$100 per day for every day he so sits or votes, and such sum may be recovered from him by any person who shall sue for the same in any court of competent jurisdiction in Saskatchewan and one-half of such sum shall belong to the person so suing and the other half shall belong to the province and be paid over to the Provincial Treasurer.

## SPEAKER AND DEPUTY SPEAKER

**Speaker**

**17(1)** The Legislative Assembly, on its first assembling after a general election, shall proceed with all practicable speed to elect one of its members to the Speaker.

(2) In case of a vacancy happening in the office of Speaker by death, resignation or otherwise, the Legislative Assembly shall proceed with all practicable speed to elect another of its members to be Speaker.

(3) The Speaker shall preside at all meetings of the Legislative Assembly.

**Deputy Speaker**

**18** The Legislative Assembly may elect a Deputy Speaker, and whenever the Speaker from illness or other cause finds it necessary to leave the chair during any part of the sittings of the House in any day he may call upon the Deputy Speaker, or in his absence upon any member of the House, to take the chair and act as Speaker during the remainder of such day, unless the Speaker himself resumes the chair before the close of such sitting of that day; and the Deputy Speaker or the member so called upon shall take the chair and act as Speaker accordingly, and every Act passed and every order made and thing done by the Legislative Assembly while such Deputy Speaker or member is acting as Speaker as aforesaid shall be as valid and effectual to all intents and purposes as if the Speaker himself were presiding in the chair.

**When Speaker absent Deputy Speaker to perform duties**

**19** Whenever the House is informed by the clerk at the table of the unavoidable absence of the Speaker, the Deputy Speaker, if present, shall take the chair and shall perform the duties and exercise the authority of the Speaker in relation to all proceedings of the House until the meeting of the House on the next sitting day, and so on from day to day on the like information being given to the Assembly until the Assembly otherwise orders.

**When both absent Assembly to elect acting Speaker**

**20** Whenever the House is informed by the clerk at the table of the unavoidable absence of both the Speaker and the Deputy Speaker, it shall be lawful for the said Assembly to elect a member to take the chair and act as Speaker for that day.

**Validity of proceedings**

**21** Every Act passed and every order made and thing done by the said Assembly while such member is acting or presiding as Speaker as aforesaid shall be as valid and effectual to all intents and purposes as if the Speaker himself were presiding in the chair.

**Decision of questions**

**22** Questions arising in the Legislative Assembly shall be decided by a majority of votes other than those of the Speaker or acting Speaker; and when the votes are equal, but not otherwise, the Speaker or acting Speaker shall have a vote.

**Allowances to Speaker and Deputy**

**23** Such allowances shall be payable to the Speaker and Deputy Speaker as may be voted by the Legislative Assembly.

**POWERS AND PRIVILEGES OF ASSEMBLY****May compel attendance of persons, etc.**

**24** The Legislative Assembly may at all times command and compel the attendance before the Assembly, or before any committee thereof, of such persons and the production of such papers and things as the Assembly or committee may deem necessary in any of its proceedings or deliberations.

**Speaker may issue warrant for attendance**

**25** Whenever the Legislative Assembly requires the attendance of any person before the said Assembly, or before a committee thereof, the Speaker may issue a warrant or subpoena directed to the person named in the order of the Legislative Assembly requiring the attendance of such person before the Legislative Assembly or a committee thereof and the production of such papers and things as may be ordered.

**When Speaker may issue order for extra-mural examination**

**26(1)** When the evidence of any person is required in connection with any matter which is the subject of inquiry by the Assembly or a committee thereof, and it is necessary to take such evidence outside the Assembly or committee, the Speaker, when thereunto authorised by a resolution of the Assembly, may make an order for the examination upon oath before any person, and at any place, of such person.

(2) For the purposes of this and sections 24 and 25 the Assembly shall be a court and shall possess all the rights, powers and privileges of a court of record.

**Witnesses may be examined under oath before committee**

**27** Any standing or special committee of the Legislative Assembly may require the facts, matters and things relating the subject of inquiry to be verified or otherwise ascertained by the oral examination of witnesses or otherwise and may examine such witnesses upon oath, and for that purpose the chairman or any other member of such committee may administer to any witness an oath or affirmation in form A or form B.

**No liability for act done under authority of Assembly**

**28** No person shall be liable in damages or otherwise for any act done under the authority of the Legislative Assembly and within its legal power or under or by virtue of any warrant or subpoena issued under such authority; all such warrants may command the aid and assistance of all sheriffs, constables and others and every refusal or failure to give such aid or assistance when required shall be an infringement of this Act.

**Member not liable to civil action or prosecution**

**29** No member of the Legislative Assembly shall be liable to any civil action or prosecution, arrest, imprisonment or damages by reason of any matter or thing brought by him by petition, bill, resolution, motion or otherwise or by reason of anything said by him before the said Assembly.

**Except for breach of this Act member not liable to arrest in civil action during session**

**30** Except for any breach of this Act no member of the said Assembly shall be liable to arrest, detention or molestation for any debt or cause whatever of a civil nature within the legislative authority of the province during a session of the Legislature.

**Exemptions from service or attendance as jurors, of members, etc.**

**31** During the time the Legislative Assembly is in session all members, officers and employees of the said Assembly and all witnesses summoned to attend before the same or any committee thereof shall be exempt from serving or attending as jurors before any court of justice in the province.

**No member to accept compensation for promoting any bill submitted to Assembly**

**32** No member of the Legislative Assembly shall accept or receive either directly or indirectly any fee, compensation for or reward for or in respect of the promoting of any bill, resolution, matter or thing submitted or intended to be submitted to the consideration of the said Assembly or any committee thereof.

**Penalty**

**33** Any person violating the provisions of section 32 shall be subject to a penalty of \$500 over and above the amount or value of the fee, compensation or reward accepted or received by him to be paid with full cost of suit to anyone who shall sue therefor; one-half thereof to be paid to the person so suing and the other half to His Majesty for the public use of the province.

**Further penalty**

**34** In case judgment be recorded against any member of the Legislative Assembly for any penalty under section 33, or in case by resolution of the said Assembly it is declared that a member thereof has been guilty of a violation of section 32, the seat of such member shall thereby be vacated and the election of such member shall thereby become void, and in either case a writ shall issue for a new election as if he were naturally dead and the said member shall *ipso facto* be incapable of being elected to or of sitting in the Legislative Assembly during the then current term of the Legislature.

**Assembly a court**

**35** The said Assembly shall be a court and shall have all the rights and privileges of a court for the purpose of summarily inquiring into and punishing the acts, matters and things following:

- (a) assaults, insults and libels upon the members of the Legislative Assembly while in session;
- (b) obstructing, threatening or attempting to force or intimidate members of the said Assembly;
- (c) the offering to or acceptance of a bribe by any member of the said Assembly to influence him in his proceedings as such or the offering to or acceptance of any fee, compensation or reward by any member for or in respect of the promotion of any bill, resolution, matter or thing submitted to or intended to be submitted to the said Assembly or any committee thereof;
- (d) assaults upon or interference with officers of the said Assembly while in the execution of their duties;
- (e) tampering with any witness in regard to evidence to be given by him before the said Assembly or any committee thereof;
- (f) presenting to the said Assembly or any committee thereof any forged or falsified document with intent to deceive such Assembly or committee;
- (g) forging, falsifying or wrongfully altering any record of such Assembly or of any committee thereof or any document or petition presented or filed or intended to be presented or filed before the said Assembly or committee or the setting or subscribing by any person of the names of any other person in any such document or petition with intent to deceive;
- (h) the bringing of any civil action or prosecution against or the causing or affecting of any arrest or imprisonment of any member of the said Assembly for or by reason of any matter or thing brought by him by petition, bill, resolution, motion or otherwise entered by him before said Assembly;
- (i) the causing or the effecting of the arrest, detention or molestation of any member of the Assembly for any debt or cause whatever of a civil nature during any session of the Legislative Assembly;

and for the purposes of this Act the said Assembly is hereby declared to possess all such power and jurisdiction as may be necessary or expedient for inquiring into, judging and pronouncing upon the commission or doing of any such acts, matters or things and awarding and carrying into execution the punishment thereof as provided for by this Act.

**Assembly may award imprisonment upon inquiry**

**36** Every person who upon such inquiry appears to have committed or done any of the acts, matters or things mentioned in section 35 shall, in addition to any other penalty to which he may by law be subject, be liable to imprisonment for such time during the session of the Legislative Assembly then being held as may be determined by the Legislative Assembly.

**Assembly's decision final**

**37** The determination of the Legislative Assembly upon any proceedings under this Act shall be final and conclusive.

**No member deprived of rights or privileges**

**38** Except in so far as is provided in this Act, nothing herein contained shall be construed to deprive the Legislative Assembly or any committee or member thereof of any rights, immunities, privileges or powers which the said Assembly, committee or member might, but for this Act, have been entitled to exercise or enjoy.

**Appropriations from general revenue fund how made**

**39** The Legislative Assembly shall not adopt or pass any vote, resolution, address or bill for the appropriation of any part of the public revenue or of any tax or impost to any purpose which has not been recommended to the said Legislative Assembly by message of the Lieutenant Governor during the session in which such vote, resolution, address or bill is proposed.

## VACATING OF SEATS

**A member may vacate seat**

**40** Any member of the Legislative Assembly may vacate his seat therein in the manner herein provided:

**By declaration from Assembly seat**

1 He may openly in his place in the Legislative Assembly declare his wish to vacate his seat as a member, and in such case the Clerk of the Legislative Assembly shall record the same in the journals and the seat of such member shall be forthwith vacated; or

**By written resignation to Speaker**

2 He may deliver to the Speaker a statement in writing under his hand attested by two witnesses declaring his resignation of such seat; and upon the receipt thereof by the Speaker (whether during the session of the Assembly or not) the seat of such member shall become vacant.

**By written resignation to two members**

**41** If any member of the Legislative Assembly wishes to resign his seat whether during or before any session or in the interval between two sessions of the Assembly, and there be then no Speaker or such member be the Speaker, he may address and cause to be delivered to any two members of the Legislative Assembly a statement in writing under his hand attested by two witnesses declaring his resignation of such seat (form C), and upon the receipt thereof by such two members the seat shall become vacant.

**Duty of Speaker or two members on receiving resignation**

**42** The Speaker or such two members, as the case may be, upon receiving such declaration or resignation, shall forthwith address his or their warrant under his or their hand and seal or hands and seals (form D) to the Clerk of the Executive Council for the issue of a new writ for the election of a member in the place of the member so notifying his intention to resign, and such writ shall issue accordingly.

**In case of vacancy by death, etc.**

**43** Upon any vacancy in the representation of any electoral district created by death or in any way other than by resignation, any two members of the Legislative Assembly may give notice of the vacancy to the Clerk of the Executive Council and require the issue of a writ to fill the same:

Provided that in case such vacancy shall occur subsequently to a general election and before the first meeting of the Legislative Assembly thereafter, such notice and requisition to the Clerk of the Executive Council may be given by two members elect of the said Legislative Assembly of whose election the said clerk as such shall

have had due notice; and such notice, and every such notice and requisition given under this section, shall be submitted forthwith after its receipt by the said clerk to the Lieutenant Governor; and upon its return by him to the said clerk indorsed as approved the necessary proceedings shall be taken in pursuance thereof as in the case of a warrant under section 42.

**Member not to resign until declared elected**

**44** No member elect of the Legislative Assembly shall be permitted to resign under the provisions of this Act until he has been finally declared elected.

**Resignation not to affect proceedings in controverted elections**

**45** The resignation of member, shall in no way affect the conduct or result of any proceedings pending or which may thereafter be taken under the provisions of any law in force in the province respecting controverted elections.

## INDEMNITY TO MEMBERS

**Amount of indemnity**

**46** In each session of the Legislative Assembly there shall be allowed and payable to each member attending such session an allowance of \$1,800 and no more:

Provided always that a deduction at the rate of \$10 per day shall be made from the said sessional allowance for every day over and above five days on which a sitting of the Assembly is held and on which the member does not attend such sitting or a meeting of some committee thereof;

Provided further that, unless illness certified to by a qualified medical practitioner be the cause of absence, and except in the cases provided for in section 49, the sessional allowance of a member who does not attend sittings of the Assembly or meetings of some committee thereof on at least one half of the total number of sitting days in any session shall be \$10 for each day of attendance and no more.

**When no deduction for absence**

**47** In the calculation of a deduction from a member's sessional allowance on account of absence, days spent by a member of the Executive Council upon Government business outside of the Assembly and days spent by a member of the Assembly on duty with his corps in a regularly organised militia camp, or in the naval or military forces of Canada, or in any other of the naval or military forces of the Crown while such forces are on active service in consequence of war, shall not be computed.

**When payable**

**48** The said compensation may be paid from time to time as the member becomes entitled to it to the extent of \$10 for each day's attendance as aforesaid, but the remainder shall be retained by the Provincial Treasurer until the close of the session when the final payment shall be made.

**When a member does not sit for full session**

**49** If any member be elected and take his seat in the Assembly after the commencement of the session or if during the session any member cease to be a member he shall be entitled to the regular sessional allowance subject to a deduction of \$10 per day for each day of the session before taking his seat or after he ceased to be a member or both, as the case may be.

**Distance allowance to members and travelling expenses**

**50** There shall be allowed to each member in attendance at a session of the Assembly five cents for each mile of the distance between the railway station nearest to the place of residence of such member and the place at which the session is held, reckoning such distance going and coming according to the shortest railway route, together with his actual travelling expenses as determined and certified by the Speaker between his place of residence and such railway station when such distance is greater than five miles.

**Payment of members by Provincial Treasurer**

**51** The sum due to any member at the close of the session shall be calculated and paid to him by the Provincial Treasurer on the receipt by the said treasurer of a solemn declaration made by such member, which declaration shall show:

- (1) The number of days on which he has attended the session;
- (2) The number of days, if any, for which a deduction from the amount of his sessional allowance has to be made under any preceding section of this Act; and
- (3) The amount of his actual travelling expenses as determined and certified by the Speaker.

## SCHEDULE 1

*(Section 2)*

1 The Province of Saskatchewan shall be divided into fifty-nine electoral divisions which shall comprise and consist of the parts and portions of the province hereinafter described.

2 In the following descriptions where “meridians between ranges” and “boundaries of townships” or “boundaries of sections” are referred to as the boundaries of electoral divisions these expressions mean the meridians, boundaries of townships or boundaries of sections, as the case may be, in accordance with the Dominion land system of surveys and include the extensions thereof in accordance with the said system.

3 Wherever a dividing line between two ranges is mentioned as the boundary of a division the expression shall mean the surveyed line on the east boundary of the westerly range and the extension of such line southerly to intersect the north boundary of each township which lies to the south of a correction line and thence easterly along the north boundary of such township to the east boundary thereof.

4 Wherever the left bank of any stream or lake is mentioned as the boundary of a division the expression shall mean the bank of such stream or lake on the left side of a person going in the direction in which the water flows.

**Souris**

(1) The electoral division of Souris bounded as follows: Commencing at the intersection of the international boundary with the eastern boundary of Saskatchewan; thence north and following the said boundary of the said province to the intersection of the same with the north boundary of the fourth township; thence west and along the north boundary of the fourth township to the intersection of the same with the second meridian; thence north and following the said second meridian to the intersection of the same with the north boundary of the fifth township; thence west and following the north boundary of the fifth township to the intersection of the same with the dividing line between the fourth and fifth ranges west of the second meridian; thence south and following the said dividing line between the fourth and fifth ranges west of the second meridian to the intersection of the same with the international boundary; thence east and following the said international boundary to the place of commencement.

**Cannington**

(2) The electoral division of Cannington bounded as follows: Commencing at the intersection of the north boundary of the fourth township with the eastern boundary of Saskatchewan; thence north and following the said eastern boundary to the intersection of the same with the north boundary of the eighth township; thence west along the north boundary of the eighth township to the intersection of the same with the second meridian; thence north and following the said second meridian to the intersection of the same with the north boundary of the ninth township in the first range west of the second meridian; thence west and following the north boundary of the ninth township to the intersection of the same with the dividing line between the seventh and eighth ranges; thence south and following the said dividing line between the seventh and eighth ranges to the intersection of the same with the north boundary of the fifth township; thence east and following the said north boundary of the fifth township to the

intersection of the same with the second meridian; thence south and following the said second meridian to the intersection of the same with the north boundary of the fourth township in the thirty-fourth range west of the first meridian; thence east and following the north boundary of the said fourth township to the place of commencement.

**Pipestone**

(3) The electoral division of Pipestone bounded as follows: Commencing at the intersection of the north boundary of the eighth township with the eastern boundary of Saskatchewan; thence north and following the said eastern boundary of the province to the intersection of the same with the north boundary of the eleventh township; thence west and following the north boundary of the eleventh township to the second meridian; thence north and following the said second meridian to the intersection of the same with the left bank of the Qu'Appelle river in the eighteenth township; thence westerly and north-westerly and following the said left bank of the Qu'Appelle river to the intersection of the same with the east boundary of section twenty-one in the nineteenth township in the seventh range west of the second meridian; thence south and following the east boundary of sections twenty-one, sixteen, nine and four in the said nineteenth township and the east boundary of sections nine and four in township nineteen A and the east boundary of sections thirty-three, twenty-eight, twenty-one, sixteen, nine and four in the eighteenth, seventeenth, sixteenth and fifteenth townships throughout all in the said seventh range and continuing south following the east boundary of said section four produced to intersect the north boundary of the fourteenth township; thence east and following the north boundary of the fourteenth township to the intersection of the same with the dividing line between the fourth and fifth ranges; thence south and following the said dividing line between the fourth and fifth ranges to the intersection of the same with the north boundary of the thirteenth township; thence east and following the north boundary of the thirteenth township to the intersection of the same with the dividing line between the third and fourth ranges west of the second meridian; thence south and following the said dividing line between the third and fourth ranges to the intersection of the same with the north boundary of the ninth township; thence east and following the north boundary of the ninth township to the intersection of the same with the second meridian; thence south and following the said second meridian to the intersection of the same with the north boundary of the eighth township in the thirty-fourth range west of the first meridian; thence east and following the north boundary of the eighth township to the place of commencement.

**Moosomin**

(4) The electoral division of Moosomin bounded as follows: Commencing at the intersection of the north boundary of the eleventh township and the eastern boundary of Saskatchewan; thence north and following the said eastern boundary of the province to the intersection of the same with the north boundary of the nineteenth township; thence west and following the north boundary of the nineteenth township to the intersection of the same with the second meridian; thence south and following the said second meridian to the north boundary of the eleventh township in the thirty-fourth range west of the principal meridian; thence east and following the north boundary of the eleventh township to the place of commencement.



**Moose Mountain**

(5) The electoral division of Moose Mountain bounded as follows: Commencing at the intersection of the north boundary of the ninth township with the dividing line between the third and fourth ranges west of the second meridian; thence north and following the said dividing line between the third and fourth ranges to the intersection of the same with the north boundary of the thirteenth township; thence west and following the north boundary of the thirteenth township to the intersection of the same with the dividing line between the fourth and fifth ranges; thence north and following the said dividing line between the fourth and fifth ranges to the intersection of the same with the north boundary of the fourteenth township; thence west and following the north boundary of the fourteenth township to the southern production of the east boundary of section four in the fifteenth township in the seventh range; thence north and following the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three throughout the fifteenth, sixteenth, seventeenth, eighteenth, nineteenth A and the nineteenth township in the seventh range to the intersection of the same with the left bank of the Qu'Appelle river in section twenty-one in the nineteenth township; thence west and following the said left bank of the Qu'Appelle river to the intersection of the same with the dividing line between the tenth and the eleventh ranges in the eighteenth township; thence south and following the said dividing line between the tenth and eleventh ranges to the intersection of the same with the north boundary of the eleventh township; thence east and following the north boundary of the eleventh township to the intersection of the same with the dividing line between the eighth and ninth ranges; thence south and following the said dividing line between the eighth and ninth ranges to the intersection of the same with the north boundary of the tenth township; thence east and following the north boundary of the tenth township to the intersection of the same with the dividing line between the seventh and eighth ranges; thence south and following the said dividing line between the seventh and eighth ranges to the intersection of the same with the north boundary of the ninth township; thence east and following the north boundary of the ninth township to the place of commencement.

**Pheasant Hills**

(6) The electoral division of Pheasant Hills bounded as follows: Commencing at a point on the second meridian being the intersection of the same with the left bank of the Qu'Appelle river in the eighteenth township; thence north and following the said second meridian to the intersection of the same with the north boundary of the twenty-first township; thence west and following the north boundary of the twenty-first township to the intersection of the same with the dividing line between the second and third ranges west of the second meridian; thence north and following the said dividing line between the second and third ranges to the intersection of the same with the north boundary of the twenty-second township; thence west and following the north boundary of the twenty-second township to the intersection of the same with the dividing line between the fifth and sixth ranges; thence north and following the said dividing line between the fifth and sixth ranges to the intersection of the same with the north boundary of the twenty-third township; thence west and following the north boundary of the twenty-third township to the intersection of the same with the dividing line between the eighth and ninth ranges; thence south and following the said dividing line between the eighth and ninth ranges to the intersection of the same with the left bank of the Qu'Appelle river in the eighteenth township; thence north-easterly, south-easterly and easterly and following the said left bank of the Qu'Appelle river to the place of commencement.

**North Qu'Appelle**

(7) The electoral division of North Qu'Appelle bounded as follows: Commencing at a point on the dividing line between the eighth and ninth ranges west of the second meridian, the said point being the intersection of the same with the left bank of the Qu'Appelle river in the eighteenth township; thence north and following the said dividing line between the eighth and ninth ranges to the north boundary of the twenty-third township; thence west and following the north boundary of the twenty-third township to the dividing line between the twelfth and thirteenth ranges; thence north and following the dividing line between the said twelfth and thirteenth ranges to the north boundary of the twenty-fourth township; thence west and following the north boundary of the twenty-fourth township to the intersection of the same with the dividing line between the seventeenth and eighteenth ranges west of the second meridian; thence south and following the said dividing line between the seventeenth and eighteenth ranges to the intersection of the same with the left bank of the Qu'Appelle river in the twenty-first township; thence easterly and south-easterly and following the said left bank of the Qu'Appelle river to the place of commencement; excepting thereout and therefrom any part of the area comprised within the village of Fort Qu'Appelle which may lie north of the Qu'Appelle river.

**South Qu'Appelle**

(8) The electoral division of South Qu'Appelle bounded as follows: Commencing at the intersection of the north boundary of the fifteenth township with the dividing line between the tenth and eleventh ranges west of the second meridian; thence north and following the said dividing line between the tenth and eleventh ranges to the intersection of the same with the left bank of the Qu'Appelle river; thence north-westerly and westerly and following the said left bank of the Qu'Appelle river to the intersection of the same with the dividing line between the sixteenth and seventeenth ranges west of the second meridian; thence south and following the said dividing line between the sixteenth and seventeenth ranges to the intersection of the same with the north boundary of the fifteenth township; thence east and following the north boundary of the fifteenth township to the place of commencement; and adding thereto any part of the area comprised within the village of Fort Qu'Appelle which may lie north of the Qu'Appelle river.

**Lumsden**

(9) The electoral division of Lumsden bounded as follows: Commencing at the intersection of the north boundary of the fifteenth township with the dividing line between the sixteenth and seventeenth ranges west of the second meridian; thence north and following the said dividing line between the sixteenth and seventeenth ranges to the intersection of the same with the left bank of the Qu'Appelle river in the twenty-first township; thence westerly and north-westerly following the left bank of the creek known as the outlet to Last Mountain lake and the left bank of Last Mountain lake to the intersection of the same with the north boundary of the twenty-second township; thence west and following the said north boundary of the twenty-second township to the intersection of the same with the left bank of the Qu'Appelle river in the first range west of the third meridian; thence south-easterly and following the said left bank of the Qu'Appelle river to the intersection of the same with the dividing line between the twenty-third and twenty-fourth ranges in the nineteenth township; thence south and following the said dividing line between the twenty-third and twenty-fourth ranges to the intersection of the same with the north boundary of the fifteenth

**Last Mountain**

(10) The electoral division of Last Mountain bounded as follows: Commencing at a point in the dividing line between the seventeenth and eighteenth ranges west of the second meridian, said point being the intersection of the same with the left bank of the Qu'Appelle river in the twenty-first township; thence north and following the said dividing line between the seventeenth and eighteenth ranges to its intersection with the north boundary of the twenty-ninth township; thence west and following the north boundary of the twenty-ninth township to the intersection of the same with the dividing line between the twenty-third and twenty-fourth ranges west of the second meridian; thence south and following the said dividing line between the twenty-third and twenty-fourth ranges to the intersection of the same with the left bank of Last Mountain lake in the twenty-eighth township; thence north-easterly, south-westerly and south-easterly and following the said left bank of Last Mountain lake to the intersection of the same with the left bank of the Qu'Appelle river; thence north-easterly and easterly and following the said left bank of the Qu'Appelle river to the place of commencement; excepting thereout and therefrom any part of the village of Craven which may lie north of the Qu'Appelle river.

**Estevan**

(11) The electoral division of Estevan bounded as follows: Commencing at a point in the international boundary, being the intersection of the same with the dividing line between the fourth and fifth ranges west of the second meridian; thence north and following the said dividing line between the fourth and fifth ranges to the north boundary of the fifth township; thence west and following the north boundary of the fifth township to the intersection of the same with the dividing line between the seventh and eighth ranges west of the second meridian; thence north and following the said dividing line between the seventh and eighth ranges to the north boundary of the sixth township; thence west and following the north boundary of the sixth township to the intersection of the same with the dividing line between the twelfth and thirteenth ranges; thence south and following the said dividing line between the twelfth and thirteenth ranges to the intersection of the same with the international boundary; thence east and following the said international boundary to the place of commencement.

**Weyburn**

(12) The electoral division of Weyburn bounded as follows: Commencing at a point in the international boundary being the intersection of the same with the dividing line between the twelfth and thirteenth ranges west of the second meridian; thence north and following the said dividing line between the twelfth and thirteenth ranges to the north boundary of the sixth township; thence east and following the north boundary of the sixth township to the intersection of the same with the dividing line between the tenth and eleventh ranges west of the second meridian; thence north and following the said dividing line between the tenth and eleventh ranges to the intersection of the same with the north boundary of the eighth township; thence west and following the north boundary of the eighth township to the dividing line between the eleventh and twelfth ranges; thence north and following the said dividing line between the eleventh and twelfth ranges to the intersection of the same with the north boundary of the ninth township; thence west and following the north boundary of the ninth township to the intersection of the same with the dividing line between the thirteenth and fourteenth

north boundary of the fifteenth township; thence west and following the north boundary of the fifteenth township to the intersection of the same with the dividing line between the twenty-third and twenty-fourth ranges west of the second meridian; thence south and following said dividing line between the twenty-third and twenty-fourth ranges to the intersection of same with the north boundary of the eighth township; thence east and following the north boundary of the eighth township to the place of commencement.

**Willow Bunch**

**Thunder Creek**

(17) The electoral division of Thunder Creek bounded as follows: Commencing at the intersection of the north boundary of the sixteenth township with the dividing line between the twenty-third and twenty-fourth ranges west of the second meridian; thence north and following the said dividing line between the twenty-third and twenty-fourth ranges to its intersection with the left bank of the Qu'Appelle river in the nineteenth township; thence westerly and north-westerly and following the said left bank of the Qu'Appelle river to the height of land between the same and Aiktow creek; thence continuing north-westerly and following, the left bank of the said Aiktow creek and its extension west to intersect the left bank of the South Saskatchewan river in the twenty-fifth township in the fifth range west of the third meridian; thence south-westerly and following the said left bank of the South Saskatchewan river to its intersection with the north boundary of the twentieth township in the eighth range west of the third meridian; thence east and following the north boundary of the twentieth township to its intersection of the same with the dividing line between the fourth and fifth ranges west of the third meridian; thence south and following the said dividing line between the fourth and fifth ranges to its intersection with the north boundary of the fifteenth township; thence east and following the north boundary of the fifteenth township to the intersection of the same with the dividing line between the twenty-seventh and twenty-eighth ranges west of the second meridian; thence north and following the said dividing line between the twenty-seventh and twenty-eighth ranges to its intersection with the north boundary of the sixteenth township; thence east and following the north boundary of the sixteenth township to the place of commencement; excepting thereout and therefrom any part of the area hereinafter described in this Act as the electoral division of Moose Jaw City.

**Arm River**

(18) The electoral division of Arm River bounded as follows: Commencing at a point on the north boundary of the twenty-second township in the twenty-third range west of the second meridian being the intersection of the same with the east bank of Last Mountain lake; thence northerly and following the said east bank of Last Mountain lake to the intersection of the same with the dividing line between the twenty-third and twenty-fourth ranges; thence north and following the said dividing line between the twenty-third and twenty-fourth ranges to the intersection of the same with the north boundary of the twenty-eighth township; thence west and following the north boundary of the twenty-eighth township to the intersection of the same with the left bank of the South Saskatchewan river in the eighth range west of the third meridian; thence south-easterly and following the said left bank of the South Saskatchewan river to the production westerly of the left bank of Aiktow creek in the twenty-fifth township in the fifth range west of the third meridian; thence continuing south-easterly and following the said left bank of Aiktow creek to the height of land between the same and the Qu'Appelle river; thence continuing south-easterly along the left bank of the said Qu'Appelle river to the intersection of the same with the north boundary of the twenty-second township in the first range west of the third meridian; thence easterly and following the north boundary of the twenty-second township to the place of commencement.

**Hanley**

(19) The electoral division of Hanley bounded as follows: Commencing at the intersection of the north boundary of the twenty-eighth township with the dividing line between the twenty-third and twenty-fourth ranges west of the second meridian; thence north and following the said dividing line between the twenty-third and twenty-fourth ranges to the intersection of the same with the north boundary of the thirty-third township; thence west and following the north boundary of the thirty-third township to the intersection of the same with the left bank of the South Saskatchewan river in the sixth range west of the third meridian; thence south and south-westerly following the said left bank of the South Saskatchewan river to its intersection with the north boundary of the twenty-eighth township in the eighth range west of the third meridian; thence east and following the north boundary of the twenty-eighth township to the place of commencement.

**Bengough**

the North Saskatchewan river to its intersection with the dividing line between the twenty-third and twenty-fourth ranges west of the second meridian; thence north and following the said dividing line between the twenty-third and twenty-fourth ranges to its intersection with the north boundary of the fifty-second township; thence west and following the north boundary of the fifty-second township to the intersection of the same with the third meridian; thence south and following the third meridian to the intersection of the same with the left bank of the North Saskatchewan river; thence north-westerly and south-westerly following the said left bank of the North Saskatchewan river to its intersection with the north boundary of the forty-fifth township; thence east and following the north boundary of the forty-fifth township to the intersection of the same with the dividing line between the first and second ranges west of the third meridian; thence north and following the said dividing line between the first and second ranges to the intersection of the same with the westerly production of the north boundary of section eighteen in the forty-fifth township in the first range west of the third meridian; thence east and following the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in the forty-fifth township in the first range west of the third meridian to the intersection of the same with the third meridian; thence south and following the third meridian to the place of commencement.

**Shellbrook**

(46) The electoral division of Shellbrook bounded as follows: Commencing at a point in the third meridian being the intersection of the same with the left bank of the North Saskatchewan river; thence north and following the said third meridian to the intersection of the same with the north boundary of the fifty-seventh township; thence west and following the said north boundary of the fifty-seventh township to the intersection of the same with the dividing line between the twelfth and thirteenth ranges west of the third meridian; thence south and following the said dividing line between the twelfth and thirteenth ranges to the intersection of the same with the north boundary of the fifty-first township; thence east and following the said north boundary of the fifty-first township to the intersection of the same with the dividing line between the ninth and tenth ranges west of the third meridian; thence south and following the said dividing line between the ninth and tenth ranges to the intersection of the same with the north boundary of the forty-sixth township; thence east and following the north boundary of the forty-sixth township to the intersection of the same with the dividing line between the seventh and eighth ranges west of the third meridian; thence south and following the said dividing line between the seventh and eighth ranges to the intersection of the same with the north boundary of the forty-third township; thence east and following the north boundary of the forty-third township to the intersection of the same with the left bank of the North Saskatchewan river in the fifth range west of the third meridian; thence north-easterly and following the said left bank of the North Saskatchewan river to the place of commencement.

**Redberry**

(47) The electoral division of Redberry bounded as follows: Commencing at the intersection of the left bank of the North Saskatchewan river with the north boundary of the forty-third township being in the fifth range west of the third meridian; thence west and following the north boundary of the forty-third township to its intersection with the dividing line between the seventh and eighth ranges; thence north and following the said dividing line between the seventh and eighth ranges to its intersection with the north boundary of the forty-sixth township; thence west and following the north boundary of the forty-sixth township to the intersection of the same with the dividing line between the thirteenth and fourteenth ranges; thence south and following the said dividing line between the thirteenth and fourteenth ranges to its intersection with the left bank of the North Saskatchewan river in the forty-first township; thence south-easterly, easterly and north-easterly and following the said left bank of the North Saskatchewan river, to the place of commencement.

**Jack Fish Lake**

(48) The electoral division of Jack Fish Lake bounded as follows: Commencing at the intersection of the north boundary of the forty-sixth township with the dividing line between the ninth and tenth ranges west of the third meridian; thence north and following the said dividing line between the ninth and tenth ranges to the intersection of the same with the north boundary of the fifty-first township; thence west and following the north boundary of the fifty-first township to the intersection of the same with the dividing line between the twelfth and thirteenth ranges west of the third meridian; thence north and following the said dividing line between the twelfth and thirteenth ranges to the intersection of the same with the north boundary of the fifty-sixth township; thence west and following the said north boundary of the fifty-sixth township to the intersection of the same with the dividing line between the eighteenth and nineteenth ranges west of the third meridian; thence south and following the said dividing line between the eighteenth and nineteenth ranges to the intersection of the same with the left bank of the North Saskatchewan river in the forty-sixth township; thence southerly and following the said left bank of the North Saskatchewan river to the intersection of the same with the north boundary of the forty-fifth township in the eighteenth range west of the third meridian; thence east and following the said north boundary of the forty-fifth township to the intersection of the same with the dividing line between the thirteenth and fourteenth ranges west of the third meridian; thence north and following the said dividing line between the thirteenth and fourteenth ranges to the intersection of the same with the north boundary of the forty-sixth township; thence east and following the said north boundary of the forty-sixth township to the place of commencement.

**Lloydminster**

(49) The electoral division of Lloydminster bounded as follows: Commencing at the intersection of the left bank of the North Saskatchewan river with the north boundary of the forty-fifth township being in the eighteenth range west of the third meridian; thence north-westerly and following the said left bank of the North Saskatchewan river to the intersection of the same with the western boundary of the Province of Saskatchewan in the fifty-third township; thence south and following the said western boundary of the Province of Saskatchewan to the intersection of the same with the north boundary of the forty-fifth township; thence east and following the said north boundary of the forty-fifth township to the place of commencement.

**Moose Jaw City**

(50) The electoral division of Moose Jaw City comprising the area described as follows: Sections twenty-seven, twenty-eight, twenty-nine, thirty, thirty-one, thirty-two, thirty-three and thirty-four in the sixteenth township in the twenty-sixth range together with sections three; four, five and six in the seventeenth township in the twenty-sixth range all west of the second meridian.

**Regina City**

(51) The electoral division of Regina City comprising the area described as follows: The north half of sections seven and eight and all of sections seventeen, eighteen, nineteen, twenty, twenty-nine and thirty in the seventeenth township and the nineteenth range west of the second meridian together with the north half of section twelve and all of sections thirteen, fourteen, twenty-three, twenty-four, twenty-five and twenty-six and also that part of section twenty-two which may be more particularly described as follows: Commencing at the north-east corner of the said section twenty-two; thence westerly along the northerly limit of the said section eleven hundred feet to a point; thence southerly to the point of intersection of the northerly limit of the right of way of the Canadian Pacific Railway Company by the easterly limit of the said section; thence north along the said easterly limit to the place of beginning all in the seventeenth township in the twentieth range west of the second meridian.

**Saskatoon City**

(52) The electoral division of Saskatoon City comprising the area described as follows: Sections fifteen, sixteen, seventeen, eighteen, nineteen, twenty, twenty-one, twenty-two, twenty-seven, twenty-eight, twenty-nine, thirty, thirty-one, thirty-two, thirty-three and thirty-four in the thirty-sixth township in the fifth range, together with sections three, four, five and six in the thirty-seventh township in the fifth range all west of the third meridian.

**Cumberland**

(53) The electoral division of Cumberland bounded as follows: Commencing at the intersection of the north boundary of the fifty-second township with the eastern boundary of the Province of Saskatchewan; thence north and following the said eastern boundary of the province to the intersection of the same with the north boundary of the said province; thence west and following the said north boundary to the intersection of the same with the third meridian; thence south and following the said third meridian to the intersection of the same with the north boundary of the fifty-second township; thence east and following the north boundary of the fifty-second township to the place of commencement.

**Ile a la Crosse**

(54) The electoral division of Ile a la Crosse bounded as follows: Commencing at the intersection of the north boundary of the fifty-seventh township with the third meridian; thence north and following the said third meridian to its intersection with the north boundary of Saskatchewan; thence west and following the said north boundary to its intersection with the west boundary of the said province; thence south following the said west boundary to its intersection with the north boundary of the fifty-sixth township; thence east and following the said north boundary of the fifty-sixth township to its intersection with the dividing line between the twelfth and thirteenth ranges west of the third meridian; thence north and following the said dividing line between the twelfth and thirteenth ranges to its intersection with the north boundary of the fifty-seventh township; thence east following the said north boundary of the fifty-seventh township to the place of commencement.

**Cypress**

(55) The electoral division of Cypress bounded as follows: Commencing at a point on the international boundary being the intersection of the same with the dividing line between the sixteenth and seventeenth ranges west of the third meridian; thence north and following the said dividing line between the sixteenth and seventeenth ranges to its intersection with the north boundary of the eighth township; thence west and following the north boundary of the eighth township to its intersection with the west boundary of the Province of Saskatchewan; thence south and following the said west boundary of the Province of Saskatchewan to its intersection with the international boundary; thence east and following the international boundary to the place of commencement.

**Happy Land**

(56) The electoral division of Happy Land bounded as follows: Commencing at the intersection of the north boundary of the fifteenth township with the dividing line between the seventeenth and eighteenth ranges west of the third meridian; thence north and following the said dividing line between the seventeenth and eighteenth ranges to its intersection with the left bank of the South Saskatchewan river in the twenty-first township; thence north-westerly and westerly and following the said left bank of the South Saskatchewan river to its intersection with the west boundary of the Province of Saskatchewan in the twenty-second township; thence south and following the western boundary of the Province of Saskatchewan to its intersection with the north boundary of the fifteenth township; thence east and following the north boundary of the fifteenth township to the place of commencement.

**Cut Knife**

(57) The electoral division of Cut Knife bounded as follows: Commencing at the intersection of the dividing line between the seventeenth and eighteenth ranges west of the third meridian and the north boundary of the forty-first township; thence north and following the said dividing line between the seventeenth and eighteenth ranges to the intersection of the same with the left bank of the North Saskatchewan river in the forty-fifth township; thence northerly and following the left bank of the North Saskatchewan river to the intersection of the same with the north boundary of the forty-fifth township in the eighteenth range west of the third meridian; thence west and following the said north boundary of the forty-fifth township to the intersection of the same with the westerly boundary of the Province of Saskatchewan; thence south and following the western boundary of the Province of Saskatchewan to the intersection of the same with the north boundary of the forty-first township; thence east and following the said north boundary of the forty-first township to the place of commencement.

**Turtleford**

(58) The electoral division of Turtleford bounded as follows: Commencing at the intersection of the left bank of the North Saskatchewan river with the dividing line between the eighteenth and nineteenth ranges west of the third meridian in the forty-sixth township; thence north and following the said dividing line between the eighteenth and nineteenth ranges to the intersection of the same with the north boundary of the fifty-sixth township; thence west and following the north boundary of the fifty-sixth township to the intersection of the same with the western boundary of the Province of Saskatchewan; thence south and following the said western boundary of the Province of Saskatchewan to the intersection of the same with the left bank of the North Saskatchewan river; thence south-easterly and following the left bank of the North Saskatchewan river to the place of commencement.

**Tisdale**

(59) The electoral division of Tisdale bounded as follows: Commencing at the intersection of the north boundary of the fortieth township with the eastern boundary of the Province of Saskatchewan; thence north and following the said eastern boundary of the Province of Saskatchewan to the intersection of the same with the north boundary of the fifty-second township; thence west and following the north boundary of the fifty-second township to the intersection of the same with the dividing line between the ninth and tenth ranges west of the second meridian; thence south and following the said dividing line between the ninth and tenth ranges to the intersection of the same with the north boundary of the forty-sixth township; thence west and following the north boundary of the forty-sixth township to the intersection of the same with the dividing line between the fifteenth and sixteenth ranges west of the second meridian; thence south and following the said dividing line between the fifteenth and sixteenth ranges to the intersection of the same with the north boundary of the fortieth township; thence east and following the north boundary of the fortieth township to the place of commencement.
