## **CHAPTER G-5.1 REG 145**

### *The Government Organization Act*

#### **Title**

- 1** These regulations may be cited as *The Ministry of Social Services Regulations, 2007*.

#### **Ministry continued**

- 2** The department of the Government of Saskatchewan called the Department of Community Resources is continued as the Ministry of Social Services.

#### **Objects and purposes**

- 3(1)** The objects and purposes of the Ministry of Social Services are the following:

- (a) to provide the structure wherein and whereby the powers, responsibilities and functions of the Minister of Social Services may be exercised and carried out;
- (b) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan relating to the office of the Minister of Social Services in accordance with *The Department of Social Services Act*;
- (c) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan related to strengthening, enhancing and maintaining families and communities with the following objectives:
  - (i) building and maintaining strong families and communities;
  - (ii) maintaining children, wherever possible, within their families and kinship networks;
  - (iii) supporting the stable, long-term attachment of children to their families and kinship networks;
  - (iv) meeting the requirements of children in need of protection;
  - (v) supporting communities so that they may be able to provide services to children and families and to individuals who, by reason of need, age or disability, require assistance;
  - (vi) supporting housing and related services for the care or accommodation of individuals who by reason of need, age or disability are unable to fully care for themselves;
- (d) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan related to promoting the economic independence and self-reliance of individuals with the following objectives:
  - (i) reducing the dependency of individuals receiving income assistance and assistance from other related programs;
  - (ii) providing low to moderate income households with affordable, suitable and adequate housing;

- (e) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan related to housing;
- (f) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan related to the following:
  - (i) supporting the access of parents to child care and child development resources and services;
  - (ii) supporting the growth and development of children;
- (g) to co-ordinate, develop, promote and implement social, economic and other policies and programs for the benefit of persons with disabilities in Saskatchewan.
