## CHAPTER 126

### An Act respecting the Manufacture and Sale of Bread

#### Short title

1 This Act may be cited as *The Bread Sales Act*.

#### Interpretation

2 In this Act, unless the context otherwise requires, the expression:

#### “Bakeshop”

1 “**Bakeshop**” means any building, premises, workshop, room or place in which bread is made for sale, or sold.

#### Appointment

3 The council of every city, town and village shall and of inspector the council of every rural municipality may, appoint an inspector for the purpose of enforcing the provisions of this Act.

#### Licenses

4(1) Every person conducting a bakeshop shall do so only under a license to be issued by the municipality, and under regulations and conditions prescribed by bylaw of the municipality, and no license shall be issued until the medical health officer gives a certificate that all regulations and conditions have been fully complied with.

(2) Any license issued hereunder may be revoked by the council of the municipality.

(3) The fee for the license for a bakeshop where bread is made for sale shall not exceed \$5. The fee for the license for a bakeshop where bread is not made for sale shall not exceed \$1.

(4) The provisions of subsection (7) of section 450 of *The City Act*, or of subsection (7) of section 426 of *The Town Act*, shall not apply to licenses under this section.

#### Weight of bread

5(1) No person shall make bread for sale, or sell or offer bread for sale, except in loaves weighing, net weight, unwrapped, twenty ounces or forty ounces or sixty ounces, avoirdupois, and except fruit loaves which shall weigh not less than sixteen ounces avoirdupois.

(2) Bread made in Saskatchewan shall be of the above weights if weighed within twelve hours after baking; bread made elsewhere, if weighed when sold or offered for sale.

**Scales and weights in bakeshop**

**6** Every person making bread for sale shall keep, in a conspicuous and convenient place in the bakeshop, scales and weights suitable for weighing bread, and shall weigh the bread offered for sale by him at the request of any person desiring to purchase the same, and an inspector may use such scales at any time for the purpose of weighing bread found by him in the bakeshop.

**Making bread, etc., contrary to provisions of Act, an offence**

**7** Every person who makes bread for sale in contravention of the preceding sections, or who neglects to comply with the provisions of section 6, shall be guilty of an offence.

**Interfering with inspector an offence**

**8** Every person who refuses an inspector admittance to his bakeshop or who interferes with an inspector in the performance of his duties shall be guilty of an offence.

**Inspector's powers**

**9** An inspector may, at any time prior to delivery to a purchaser, weigh any bread made or offered for sale, and if, upon weighing the bread, he finds that it is of less than the prescribed weight, he shall seize and remove it and hand it over to some charitable institution.

**Duties of inspector**

**10** It shall be the duty of every inspector to see that the provisions of this Act are complied with, and he shall make a report quarterly to the council showing the prosecutions taken and the quantity of bread seized or tested under this Act.

**When penalty not to be imposed**

**11** No person shall be liable to the penalties prescribed by this Act for making or offering for sale short weight bread, unless, in the case of a manufacturer, there be found at least ten short weight loaves in any one baking when taken in rotation and weighed collectively, but all short weight loaves shall nevertheless be liable to seizure as hereinbefore provided.

**Penalties**

**12** Every person guilty of an offence under this Act shall be liable to a penalty of not less than \$5 nor more than \$50 for the first offence, and not less than \$10 nor more than \$100 for the second or any subsequent offence.
