Chapter 43

An Act respecting the Office of the Queen's Printer

Short title

1 This Act may be cited as *The Queen's Printer's Act*.

Interpretation, "minister"

2 In this Act "**minister**" means the member of the Executive Council from time to time in charge of the office of the Queen's Printer.

Staff

3 The staff of the office of the Queen's Printer shall consist of an official to be known as the Queen's Printer and such other employees as may be required.

Duties

4 The Lieutenant Governor in Council may prescribe the duties appertaining to the office of the Queen's Printer and designate a member of the Executive Council under whose direction the work of the office shall be performed.

Publication of *The Saskatchewan Gazette*

5 The Lieutenant Governor in Council may authorize the publication not less than twice in each month of an official gazette, to be styled *The Saskatchewan Gazette*, for the publication of proclamations, official and other notices and of all other matters whatever from time to time required to be published therein.

Publication of statutes, etc.

6 The Queen's Printer shall print and publish or cause to be printed and published the Statutes of Saskatchewan, the *Gazette* and such documents and announcements as may from time to time be required.

Advertisements, etc., published in *Gazette*

7 All advertisements, notices, publications or documents whatever relating to any matter within the control of the Legislature of Saskatchewan and that by any law in force in Saskatchewan are required to be published by the Government of Saskatchewan or by a department thereof or by any officer, person or party whomsoever shall, unless some other mode of publication is prescribed by law, be published in the *Gazette*.

Conditions of publication of *Gazette*

8 The Lieutenant Governor in Council shall prescribe the conditions of the publication of the *Gazette* and shall designate the public bodies, officers and persons to whom it shall be sent; and shall prescribe a tariff of charges to be paid for the publication of notices, advertisements and documents therein and the price of subscription thereto.

Charges paid in advance

9 Except as otherwise ordered by the Lieutenant Governor in Council, no notice shall be published in the *Gazette* unless the proper charges in that behalf have first been paid to the Queen's Printer.

Publication of sheriff's advertisement, etc.

10(1) All sheriff's advertisements and official advertisements shall be published in such newspapers as the Lieutenant Governor in Council may direct, but this enactment shall not be construed as authorizing the transfer from the *Gazette* to a newspaper of advertisements that are required by law to be published in the *Gazette*.

(2) Subsection (1) does not apply to advertising the whole cost of which is payable by municipalities.

Clerk of the Assembly to furnish Queen's Printer with copies of Acts, etc.

11(1) The Clerk of the Legislative Assembly shall furnish the Queen's Printer with a true copy of each Act of the Legislature as soon as practicable after it has received assent or, if a bill is reserved, as soon as the assent thereto has been signified in accordance with *The British North America Act, 1867*.

(2) The Clerk of the Legislative Assembly shall, as soon as practicable after the close of a session of the Legislature, furnish the Queen's Printer with the necessary manuscript to enable him to publish the journals of the session and the sessional papers.

Parties to whom Queen's Printer sends Acts

12 As soon as practicable after the close of a session of the Legislature the Queen's Printer shall deliver or transmit, by post or otherwise in the most economical way, the proper number of printed copies of the Acts of the Legislature, as follows:

- (a) to each member of the Legislative Assembly such number of copies as may be provided by resolution of the Assembly or, failing such resolution, by order of the Lieutenant Governor in Council;
- (b) to such public departments, administrative bodies, officers, libraries or persons in Canada or elsewhere as may be determined by order of the Lieutenant Governor in Council, such number of copies as may be so determined.

Printing, binding, etc.

13 The Queen's Printer shall, under such regulations of the Lieutenant Governor in Council as may be made in that behalf, have all printing, binding and blue-printing work done which may be required for the use of the Legislative Assembly or a department of the public service.

Treasury advances

14 The Provincial Treasurer may authorize the advance to the Queen's Printer, out of the consolidated fund, of such sums of money as the Queen's Printer may require to enable him to pay for such printing or binding or blue-printing:

Provided that the net amount of such advances shall not exceed such amount as shall be decided upon by the Lieutenant Governor in Council.

Printing, binding, etc., to be done upon requisition

15 Subject to such regulations as may be made by the Lieutenant Governor in Council, the Queen's Printer shall have printing and binding and blue-printing work done, upon requisition therefore by the permanent head of the department having charge of the service in connection with which the printing or binding or blue-printing may be required, or by an employee of the department authorized by the permanent head to sign the requisition.

Service to be required for supplies

16 The quantity supplied and the value thereof shall be charged by the Provincial Treasurer to the particular service in connection with which the supplies are required on an account thereof rendered monthly, the amount of such charge being at the same time credited to the account of the advances made by the Provincial Treasurer to the Queen's Printer.
