ORDER IN COUNCIL 109/76

under The Superannuation (Supplementary Provisions) Act – Section 6

To His Honour,

The Lieutenant Governor in Council:

The undersigned has the honour to report:

- (1) That Section 6 of The Superannuation (Supplementary Provisions) Act authorizes The Power Corporation Superannuation Board with approval of the Lieutenant Governor in Council, to enter into a Reciprocal Agreement with The University of Saskatchewan.
- (2) That The Power Corporation Superannuation Board has entered into a Reciprocal Agreement with The University of Saskatchewan.
- (3) That Section 98 of The University of Saskatchewan Act reads:
 - "Where the University of Saskatchewan is referred to in any other Act of the Legislature, the Lieutenant Governor may define for the purposes of any other Act, the expression "The University of Saskatchewan" as meaning or including The University of Regina."
- (4) That The University of Regina has requested The Power Corporation Superannuation Board to enter into a Reciprocal Agreement with it.
- (5) That Section 6 of The Superannuation (Supplementary Provisions) Act provides that a Reciprocal Agreement may be retroactive in effect and that the terms and provisions of an agreement entered into under that section shall have the same effect as if incorporated in The Power Corporation Superannuation Act.
- (6) That Section 6 of The Superannuation (Supplementary Provisions) Act outlines the terms of a Reciprocal Agreement and provides that the Lieutenant Governor in Council may authorize payment in accordance with the terms of the Agreement and said Section 6.
- (7) That it is deemed advisable for The Power Corporation Superannuation Board to enter into a Reciprocal Agreement with The University of Regina and to give retroactive effect to that Agreement.

The undersigned has the honour, therefore, to recommend that Your Honour's Order do issue under Section 6 of The Superannuation (Supplementary Provisions) Act and Section 98 of The University of Saskatchewan Act, 1974, making the order set out below.

ORDER:

His Honour the Lieutenant Governor in Council, upon the recommendation of the Minister-In-Charge of Saskatchewan Power Corporation, acting pursuant to Section 6 of The Superannuation (Supplementary Provisions) Act and Section 98 of The University of Saskatchewan Act, 1974, hereby:

- (1) Defines the expression "The University of Saskatchewan" as used in Section 6 of The Superannuation (Supplementary Provisions) Act to mean and include The University of Regina for purposes of that Act.
- (2) Grants approval to The Power Corporation Superannuation Board established under The Power Corporation Superannuation Act, to enter into a Reciprocal Agreement which Agreement may be retroactive in effect, with the following public service employer The University of Regina.
- (3) Deems it necessary to authorize payment of certain sums to give full effect to the purpose and intent of Section 6 of The Superannuation (Supplementary Provisions) Act and to any agreement entered into under subsection 2 of Section 6 of that Act and does hereby authorize the payment of such sums.
