## CHAPTER 46

### An Act respecting Crown Timber and Provincial Forests

#### SHORT TITLE

##### Short title

- 1 This Act by be cited as *The Forest Act*.

#### INTERPRETATION

##### Interpretation

- 2 In this Act:

##### “Crown”

1. “**Crown**” means Her Majesty the Queen in right of Saskatchewan;

##### “Crown timber”

2. “**Crown timber**” includes any trees, timber and products of the forest in respect whereof the Crown is enabled to demand and receive any royalty or revenue or money;

##### “department”

3. “**department**” means the Department of Natural Resources;

##### “forest land”, “timber land”

4. “**forest land**” or “**timber land**” includes any uncultivated land in the province on which trees or shrubs are growing or standing, and any barren, dry marsh, or bog, whether such land is owned by the Crown or by private persons, or held under lease from the Crown;

##### “mines”

5. “**mines**” and “**minerals**” means mines and minerals as defined in *The Provincial Lands Act*;

##### “minister”

6. “**minister**” means the Minister of Natural Resources;

##### “officer”

7. “**officer**” means any person employed in connection with the administration and management of the department;

##### “provincial lands”

8. “**provincial lands**” means provincial lands as defined in *The Provincial Lands Act*;

##### “pulpwood berth”

9. “**pulpwood berth**” means an area in respect of which a licence has been issued to cut and remove pulpwood;

10. “**timber berth**” means an area in respect of which a licence has been issued to cut and remove timber.

## PART I

**Administration****Department to administer Act**

**3(1)** This Act and the regulations thereunder shall be administered by the department.

(2) An officer may be appointed to manage and direct such administration under the control of the minister, and also such other officers, clerks and employees as are deemed necessary.

**Duties of department**

**4** The department shall control and administer all matters relating to or in any way connected with forestry, and without restricting the generality of the foregoing shall control, regulate and administer:

- (a) all rights, properties, interests, claims and demands of the Crown in Crown timber;
- (b) all revenues and money of the Crown arising from forestry, Crown timber and grazing and hay on provincial forests;
- (c) conservation of forests;
- (d) reforestation;
- (e) prevention of forest fires;
- (f) sales and disposition of Crown timber; and
- (g) the cutting, classifying, measuring, manufacturing, branding, and the inspection of trees, timber and the products of the forest.

**Appointment of Saskatchewan Forest Products as agent of minister for certain purposes**

**5** Saskatchewan Forest Products, being a corporation under the provisions of *The Crown Corporations Act*, is hereby appointed as agent of the minister for the purpose of developing and utilizing the forest resources of the province, subject to the control of the minister and to the provisions of this Act and the regulations.

**No acquisition of Crown timber except under Act**

**6** No person shall acquire any right to or property in Crown timber except in accordance with this Act and the under Act regulations.

**Power to constitute forest districts**

**7** The Lieutenant Governor in Council may constitute any portion or portions of the province a forest district, and declare by what local name it shall be known, and may extend, reduce, subdivide or annul the constitution of any existing forest district or merge it in whole or in part in the consolidation of two or more forest districts.

**Employees not to hold property from Crown**

8(1) No employee of the department shall have, acquire or hold, directly or indirectly, any property or interest in any timber berth or timber licence or authority from the Crown to utilize or deal with any timber or product of the forest, or engage or have any interest in any business having as its object the utilization of or dealing in timber or products of the forest.

(2) Notwithstanding the provisions of subsection (1), the Lieutenant Governor in Council may authorize the issuance of a permit under the regulations to an employee of the department who during the war of 1939-1945 served in any of His Majesty's forces or in any of the forces of His Majesty's allies, authorizing such employee to cut timber for his own use.

**Annual report**

9 The minister shall annually lay before the Legislative Assembly within the first fifteen days of the session a report of the proceedings, transactions and affairs of the department during the year next preceding in so far as they concern Crown timber and provincial forests.

**Regulations**

10(1) The Lieutenant Governor in Council may from time to time make such regulations, not inconsistent with this Act, as are necessary to carry out its provisions according to their obvious intent or to meet cases which may arise and for which no provision is made by this Act.

(2) Every regulation so made shall, unless otherwise specially provided in this Act, have force and effect only after the same has been published in *The Saskatchewan Gazette* or on and after a date to be named in the regulation; and all such regulations shall be laid before the Legislative Assembly within the first fifteen days of its next meeting.

(3) Such regulations shall have the same force and effect as if enacted herein.

**Disposition of Crown Timber**

## TIMBER AND PULPWOOD LICENCES

**Regulations governing disposal of timber**

11 The Lieutenant Governor in Council may make regulations for the disposal by public competition, by agreement in accordance with forest management plans and by agreement with Saskatchewan Forest Products, or by any of such methods of disposal, of the right under licence, sale or contract to cut Crown timber.

**Power of minister to sell**

**12** The minister may, at the instance of any applicant, or otherwise, advertise for sale and sell by public competition, or sell to Saskatchewan Forest Products, in the manner prescribed in the regulations, a licence to cut and remove any Crown timber that is subject to disposition by the Crown.

**Same**

**13** Subject to the approval of the Lieutenant Governor in Council, the minister may, by agreement in accordance with a forest management plan, sell a licence to cut and remove any Crown timber that is subject to disposition by the Crown.

**Contents of offers**

**14** Every offer to purchase a licence shall include an offer on behalf of the person making the same to pay in advance to the Crown, in addition to all royalties, dues and taxes reserved or imposed by statute or regulation:

- (a) the cost incurred by the department in cruising, surveying and advertising the proposed timber limit for sale;
- (b) an annual ground rental based on the acreage contained in the lands covered by the licence or permit;
- (c) such stumpage or additional sum, being not less than the upset price fixed by the minister, as the person making the offer is willing to pay for the privileges of the licence.

**Scaling and measurements, etc.**

**15(1)** The minister may require that all or any Crown timber authorized to be cut from provincial lands under licence, permit or sale shall be scaled, measured or counted prior to manufacture in accordance with the terms of the contract governing the disposition of the timber.

**(2)** No person is authorized to scale timber cut upon provincial lands or forests other than an officer of the department or those authorized in writing by the minister or his appointed agent.

**Sawmills**

**16(1)** No person shall establish or operate a sawmill on provincial lands, except holders of berths or licences from the Crown to cut timber, without first obtaining a licence from the department.

**(2)** Licences to establish and operate sawmills shall require the owners or operators thereof to comply with all regulations respecting the manner of disposing of waste from sawmills and for protecting the adjoining forest from fire, as well as the requirements of *The Boiler and Pressure Vessel Act*.

**Disposal of slash from lumbering operations**

17(1) If as a result of operations for the cutting or removal of trees or timber, any slash, including in that expression any brush or debris, is occasioned or accumulated, the person carrying on the operation shall, on the demand of any officer authorized by the minister, dispose of the slash by burning or otherwise to the satisfaction of the minister.

(2) If any person fails or neglects to dispose of any slash at the time and in the manner required under this section, the minister may dispose of the slash, in which case all expense incurred therein shall be forthwith due and payable to the Crown from that person.

(3) The Crown shall have a lien for the amount of any expense so payable to the Crown, and for all expenses of seizure, detention or sale incurred in enforcing the lien, upon all engines, logging plant, equipment and material used in the operation in which the slash was occasioned or accumulated, or belonging to the person carrying on the operation, and also against the lands upon which the operation in which the slash was occasioned or accumulated was in whole or in part carried on.

(4) The lien mentioned in subsection (3) shall constitute a charge to the like extent, and shall confer the same rights, and shall be registrable and enforceable in the same manner as the liens created by this Act for the recovery of royalties, including an absolute, unconditional power to sell.

(5) All moneys payable under this section shall also be a debt due to the Crown recoverable by action in any court of competent jurisdiction.

**Fireguard around debris from industrial operations**

18 Where the safety of any forest or woodland or timber is endangered by the debris caused by any lumbering or other industrial operation, the minister may require the person conducting the operation, or the owner or occupier of the land on which the debris exists, to cut down all dead trees and stubs within the area, and to establish a safe fireguard around the area covered by the debris, such fireguard to be cleared of inflammable material and to be of a width and character satisfactory to the minister.

**Fireguard around camps and engines**

19 Every camp, mine, sawmill, portable or stationary engine located in or within one-half of a mile from any forest or woodland shall, by the person in charge thereof, have such space surrounding the camp, mine, sawmill or engine cleared of inflammable material, as the minister may direct.

**Burning of debris caused within 300 feet of railway**

20 Every person who, within three hundred feet of the right of way of any railway, causes any accumulation of inflammable debris shall immediately pile and subject to the requirements of *The Prairie and Forest Fires Act*, burn the same.

**Power of minister to do work and recover expenses**

**21(1)** If, after due notice, any person fails to carry out any requirements of section 17, 18, 19 or 20 to the satisfaction of the minister, then, in addition to any other penalty imposed by this Act, the minister may by his officer enter upon the land on which the debris, dead trees, stubs, inflammable material, refuse timber, slash, choppings or brush in question exist and carry out those requirements and the orders of the minister issued thereunder.

(2) Where the minister has taken action under subsection (1) the Crown shall have a lien for the amount of the expenses incurred thereby, and for all expenses of seizure, detention or sale incurred in enforcing the lien, upon the lands, sawmills, engines, logging plant and equipment of the person making default. Such lien shall constitute a charge to the like extent and shall confer the same rights and be registrable and enforceable in the same manner as the liens created by this Act for the recovery of royalties, including an absolute, unconditional power to sell.

(3) Such expenses shall also be a debt due to the Crown recoverable by action in any court of competent jurisdiction from the person who cut the trees or timber from which the debris or other material in question was made.

**Timber berth licence**

**22(1)** The person to whom a timber berth is awarded shall be granted a licence therefor, which shall describe the land upon which the timber may be cut and the dimension thereof.

(2) Every timber berth shall, during its continuance:

(a) vest in the licensee, all rights of property in all trees, timber, lumber or other products of timber which he is entitled by the licence to cut and which have been cut within the limits of the berth during the continuance thereof, whether such trees, timber, lumber or other products are cut by consent of the licensee or by any other person without his consent; and

(b) vest in the licensee, as against any person other than the Crown, subject to the conditions mentioned in the licence, all rights of property in all trees, timber, lumber and other products of timber, which the licensee is not entitled to cut but which are cut within the limits of the berth by any other person without his consent.

(3) Such licence shall entitle the licensee:

(a) to seize in replevin or otherwise, as his property, timber of any kind cut within the limits of the berth where it is found in the possession of an unauthorized person;

(b) to bring action or suit against any person unlawfully in possession of such timber; and

(c) to prosecute all persons cutting timber of any kind in trespass, or entering without authority upon the berth covered by the licence, to conviction and punishment and to recover damages, if any;

and all proceedings pending at the of the licence may be continued and completed as if the licence had not expired.

**Duration of licence**

**23(1)** The licence shall be for a term not exceeding one year, but shall be renewable from year to year. The licences for timber berths sold previously to the first day of April, 1931, shall be renewable from year to year while timber of the kind and dimensions described in the licence remains in sufficient quantity to make it commercially valuable, such renewal being subject to the payment of such dues and to such terms as are fixed by the regulations in force at the time the renewal is made.

(2) On every application for renewal of a licence, the minister shall be the judge as to whether the terms and conditions of the licence and the provisions of this Act and the regulations respecting timber berths have been fulfilled.

***Workmen's Compensation (Accident Fund) Act***

**24** Notwithstanding anything contained in this Act, no timber or pulpwood berth shall be awarded, no pulpwood licence or licence to cut and remove Crown timber shall be sold or issued, no permit to cut timber in excess of fifty thousand feet board measure, or the equivalent thereof in other timber products, shall be issued, and no permit to establish or operate a sawmill on provincial lands shall be issued, unless the applicant has filed with the minister evidence satisfactory to him that the applicant has complied with the provisions of *The Workmen's Compensation (Accident Fund) Act*.

**Further conditions of all licences**

**25** There shall be implied in every licence, in addition to such other provisions as are contained in the regulations or in the conditions under which the berth was disposed of, provisions binding the licensee:

(a) in the case of timber berths, to erect and have in operation in connection with the berth, within one year from the date upon which he is ordered to do so by the minister, a sawmill or sawmills capable of cutting in twenty-four hours two thousand feet board measure for every two and a half square miles of the berth, and to keep such mill or mills in operation for at least three months in each year during the continuance of his licence:

provided that where the minister is satisfied that the failure to keep such mill or mills in operation for at least three months in any year is attributable to an Act of God, he may, for such period as he considers reasonable, relieve the licensee from compliance with the provision, but upon the expiration of the prescribed period the licensee shall comply with such provision unless he is again relieved therefrom by the minister;

(b) to pay in advance, in addition to the bonus or bid, such annual ground rent as is fixed by the regulations and in addition thereto, to pay in cash, at each time of making the returns prescribed in clause (d), such dues as are fixed by the regulations;

(c) to keep correct books of account of his business, and to submit them for the inspection of any authorized agent of the minister when required;

- (d) to make to the department monthly, or at such other intervals of time as they are required of him by regulations made under this Act or by the minister, returns sworn to by him or by his agent or employee cognizant of the facts, with all the details of his timber operations in such form and manner as the regulations provide;
- (e) to prevent any unnecessary waste of timber in the process of cutting it, and to prevent all avoidable destruction of growing trees which have not attained the dimensions described in the licence;
- (f) to exercise strict and constant supervision to prevent the origin and spread of fire; and to comply during the term of the licence and of any renewal thereof, with all laws or regulations in that respect in force in the province;
- (g) to pay one-half of the cost incurred by the Crown in guarding such timber berth from fire.

#### **Error in survey**

**26** If, in consequence of any incorrectness in survey or other error or cause, a licence is found to cover land covered by another licence of prior date, or any land sold, granted, leased or lawfully set apart for any other purpose under this Act, the later licence shall be void in so far as it interferes with any such previous lease, licence, sale, grant or setting apart.

#### **Reservation of Crown rights**

**27(1)** Every licence or permit to cut timber shall be subject to the provisions of this Act, or of any other Act, or of any regulations made thereunder, dealing with or affecting the disposition of Crown rights within or under lands within the boundaries of the timber berth; and in or by virtue of any grant, lease or permit issued under regulations so made, the grantee, lessee or permittee shall have the right to secure, use and hold possession of such land as is described in the grant, lease or permit, for the purposes named therein, and the right to open any roads necessary in connection therewith:

Provided that the grantee, lessee or permittee shall pay to the licensee of the berth the value of all timber cut, damaged or destroyed as a consequence, directly or indirectly, of such authorized operations.

- (2) The holder of the timber licence or permit shall be notified of every grant, lease or permit made or issued which affects the rights conferred by his licence or permit.
- (3) The provisions of this section apply to every licence or permit to cut timber granted prior to the first day of April, 1931.

#### **Withdrawal of portion of timber berth from licence after notice**

**28(1)** When, in the opinion of the minister:

- (a) any portion of a timber berth has not a sufficient quantity of the kind and dimensions of timber specified in the licence for such berth to make it profitable to remove the timber thereupon; and

(b) such portion is not necessary for the proper working of the remainder of the berth;

the minister may, upon the expiration of sixty days after notice in writing of the proposed withdrawal has been given to the licensee or his legal representative, withdraw that portion from the berth.

(2) Upon the withdrawal of any portion of a timber berth, the rental to be paid under the licence shall be reduced in proportion to the area withdrawn.

**Licences and sales subject to regulations**

**29** All licences and timber sales and renewals thereof for timber or for pulpwood berths shall be subject to such provisions of this Act and the regulations as provide for the protection of the forest and the protection of game, birds, fish and other animals, and the prevention of fires therein and the preservation and reproduction of timber.

**Permits to cut timber**

**30(1)** The Lieutenant Governor in Council may make regulations for the issue of permits to cut timber:

- (a) to actual settlers, for use for building purposes on their farms or for fuel for themselves;
- (b) to persons engaged in explorations, in scientific pursuits or in prospecting;
- (c) to steamboat owners, for use on their steamboats;
- (d) for the construction of boats;
- (e) in connection with quarrying or mining, or salt, oil or gas boring operations;
- (f) for the construction of railways, roads, bridges, churches, schools and public buildings, or any public work;
- (g) for sale as cordwood;
- (h) for pulpwood.

(2) The Lieutenant Governor in Council may make regulations:

- (a) for sale by public competition of timber from provincial lands not to exceed \$25,000 in value in dues in any one sale, and for a period of removal not to exceed eight years;
- (b) for the control and supervision of sawmills where any portion of the timber sawn in such sawmills has been secured from provincial lands.

**Standardization of cutting operations with respect to certain trees**

**31(1)** Notwithstanding anything contained in any Act or in any regulations under any Act or in any timber berth licence, timber sale agreement, licence to cut timber or permit to cut timber or in any renewal thereof, whether issued or made before, on or after the first day of October, 1930, and irrespective of who may be the parties thereto, no licensee, purchaser or permittee shall have the right, power or licence to cut, for saw timber or railway ties, and no licensee, purchaser or permittee shall cut, for saw timber or railway ties, timber on the lands described in the licence, agreement or permit of a diameter, measured outside the bark, less than:

- twelve inches in the case of white spruce;
- eleven inches in the case of jack pine;
- twelve inches in the case of tamarack;
- eight inches in the case of poplar;

when measured four and one-half feet from the ground, and the conditions and restrictions of the licence, agreement or permit or any renewal thereof shall be read as modified accordingly.

(2) Nothing in subsection (1) applies to the cutting of such timber as may be necessary for the construction of roads or other works to facilitate the taking out of merchantable timber, or to the cutting of timber killed or damaged by fire, wind, insects or fungi or required to be removed for the improvement or development of a stand of timber or for other silvicultural reasons and which is specified in the licence, agreement or permit or marked or otherwise designated by an officer for cutting.

(3) Subsection (1) does not affect any right which the licensee, purchaser or permittee may have to renewal of the licence, agreement or permit save that any renewal made shall be subject to the provisions of subsection (1).

**Forfeiture of licence or permit**

**32(1)** Every licence, permit or area shall be liable to forfeiture on the order of the minister for violation of any of the conditions to which it is subject or for a fraudulent return.

(2) Before making an order for forfeiture the minister shall cause written notice to be given to the licensee, permittee or purchaser of his intention so to do, upon grounds set forth in the notice, unless within ninety days after service of the notice the licensee, permittee or purchaser shows cause to the contrary as provided in this section.

(3) Service of such notice may be effected by mailing it, duly registered, to the address or the last known address of the licensee, permittee or purchaser, and in such case shall be deemed to have been made upon the day on which the notice reached the said address or in due course of mail should have done so.

(4) The licensee, permittee or purchaser may within the said period of ninety days apply by petition to the judge of the district court for the judicial district in which the lands are situated, for an order declaring that there is no sufficient cause for the forfeiture of his licence, permit or area.

(5) Upon the filing of the petition the judge shall appoint a time and place for the hearing, and shall give directions for service upon the minister, and upon any other persons interested, of a copy of the petition and of a notice of the time and place appointed.

(6) At such time and place, or at any other time and place to which the hearing is adjourned, the judge shall hear and dispose of the matter of the petition in a summary way, and by his order shall determine whether or not there is sufficient cause for the forfeiture, and, if he finds in the affirmative, what such cause is.

(7) The order of the judge shall be subject to appeal in like manner as his decision upon the trial of an action, and he shall have the same jurisdiction as to costs and otherwise as in matters in court under his jurisdiction.

(8) Pending the final disposal of the petition the minister shall not exercise the power of forfeiture.

#### **Lien of Crown for dues**

**33(1)** All dues on timber cut within a timber berth or under a timber sale agreement or under a permit which are not paid at the time when they are payable shall bear interest at the rate of seven per cent per annum until paid, and shall be a lien on any timber cut within the berth or under the agreement or permit.

(2) Where such sums are overdue and unpaid, whether in consequence thereof the licence of the berth or the timber sale agreement or the permit has or has not been cancelled, an officer or any person authorized by the minister may seize so much of the timber cut on the berth or under the sale agreement or under the permit as will, in his opinion, be sufficient to secure payment of the dues, the interest thereon, and the expenses of seizure and sale, and may detain the timber as security for payment.

(3) Where timber has been seized under subsection (2) and payment is not made within one month after the seizure, any officer acting under instructions from the minister may sell the same by public auction, in which case, after deducting the sum due, the interest thereon and the expenses of seizure and sale, he shall pay over the balance, if any, to the licensee, purchaser or permittee, if the timber was in his possession at the time of seizure, or, if it was not, to the person who had possession thereof at that time:

Provided that, if a bid is not made at the auction amounting to the sum equal to the claim against the licensee, purchaser or permittee, the timber may be disposed of by private sale.

#### **Timber liable for dues**

**34(1)** All timber cut under licence, sale agreement or permit shall be liable for the payment of the dues thereon, whenever and wherever the timber, or any part of it, is found, whether it is or is not converted into deals, boards or any other manufacture of wood; and all officers or agents employed in the collection of such dues may follow the timber and may seize and detain it wherever it is found until the dues thereon are paid or secured as provided in section 33.

(2) No unmanufactured saw-logs, with respect to which the Crown dues or royalties have not been paid, shall be removed out of the province without the written approval of the minister, and as a condition to such approval the minister may require the licensee, purchaser, permittee or applicant, as the case may be, to furnish a bond in such amount as the minister may determine guaranteeing payment of the dues on such timber.

**Enforcement of payment in case of removal out of Saskatchewan**

**35** If payment of the dues on any timber has been evaded by removal of the timber or the products thereof out of Saskatchewan, or otherwise, the amount of the dues, and any expenses incurred in enforcing payment, may be added to the dues remaining to be collected on any other timber cut on any timber berth by the licensee or purchaser under sale agreement or cut under permit by the permittee, or by authority of the licensee, purchaser or permittee, and may be levied on such timber and collected, together with the last mentioned dues, in the manner hereinbefore provided. The amount due of which payment has been evaded shall also be recoverable by action or suit, in the name of the minister or his agent, in any court of competent jurisdiction.

**36** The minister may take or authorize the taking of promissory notes for any money due to the Crown by a licensee, purchaser under sale agreement or permittee, or in his discretion, of bonds for not less than double the amount of any dues, and the penalties and costs incurred, and may, if it is under seizure, then release any timber upon which the debt would be leviable; but the taking of such notes or bonds shall not affect the right to enforce payment of the debt, and the debt shall be a lien on any timber cut by the licensee, purchaser or permittee or by his authority, if the sums for which or to secure which the notes or bonds are given are not paid when due.

## CUTTING HAY OR TIMBER WITHOUT AUTHORITY

**Cutting hay or timber without authority**

**37(1)** If any person, without authority, cuts or employs or induces any other person to cut or assist in cutting, hay or timber on provincial lands, or removes or carries away, or employs or induces or assists any other person to remove or carry away, hay or timber so cut, he shall not acquire any right to such hay or timber, or any claim or remuneration for cutting it, preparing it for market, or conveying it to or towards market.

(2) When hay or timber, cut without authority, has been removed out of reach of the officers, or it is otherwise found impossible to seize it, the person so acting without authority is, in addition to the loss of his labour and disbursements, liable to a penalty not exceeding \$3 for each tree or load of hay which, or any part of which, he is proved to have cut or removed or carried away, or assisted to cut or carry away or employed or induced any other person to cut or carry away; and such sum shall be recoverable, with costs, at the suit and in the name of the Crown, in any court of competent jurisdiction.

(3) In suits for penalties under subsection (2) the burden of proof of authority to do the thing charged shall lie on the person charged; and the averment of the person seizing or prosecuting, that he is employed under the authority of this Act, shall be sufficient proof thereof, unless the defendant proves the contrary.

**Power to seize hay or timber unlawfully cut**

**38** If an officer receives satisfactory information that hay or timber has been cut, without authority or without proper observance of the regulations or the conditions of the licence, sale agreement or permit on provincial lands, or is aware that hay or timber has been cut, without authority, or without proper observance of the regulations or the conditions of the licence, sale agreement or permit on such lands, he may seize, or cause to be seized in Her Majesty's name, the hay or timber so reported or known to be cut, wherever it is found, and place it under proper custody until the matter is decided by competent authority.

**Case of mixtures**

**39** If the hay or timber reported or known to have been cut without authority, has been made up with other hay or timber, or been so mixed up with other hay or timber as to render it impossible or very difficult to distinguish the hay or timber so cut without authority from the other hay or timber, the whole shall be held to have been cut without authority, and shall be liable to seizure and forfeiture accordingly, unless the holder separates, to the satisfaction of the officer, the hay or timber cut without authority, from the other.

**Detention in case of doubt**

**40** If an officer is in doubt as to whether hay or timber has been cut without authority, or is liable to dues to the province, on the whole or any part thereof, he may inquire of the person or persons in possession or in charge of the hay or timber, as to when and where the same was cut; and if no satisfactory explanation, on oath or otherwise, as he requires, is given to him, he may seize and detain such hay or timber until proof is made to the satisfaction of the minister, or of any officer specially authorized by the minister, that the hay or timber was not cut without authority, and is not liable, either in whole or in part, to dues of any kind; and if such proof is not made within thirty days after such seizure, the hay or timber may be dealt with as hay or timber cut without authority, or on which dues have not been paid, according to the circumstances of the case; and the dues thereon may be recovered as hereinafter provided.

**Release on giving bond or security**

**41** If hay or timber, or any product thereof, is seized under the provisions of this Act by an officer, he may allow such hay or timber, or product thereof, to be removed and disposed of, on receiving sufficient security, to his satisfaction, for the full value thereof, or, in his discretion, a satisfactory bond for payment of double the amount of all dues, penalties and costs, incurred or imposed thereon.

**Forfeiture and sale of hay or timber seized**

**42(1)** Hay or timber seized under this Act shall be deemed to be forfeited unless the owner thereof, or the person from whom it was seized, within one month from the date of seizure, gives notice to the seizing officer or to the minister that he intends to contest the seizure.

- (2) If:
- (a) the claimant having given such notice, does not, within fifteen days thereafter, institute proceedings before a court of competent jurisdiction to contest the seizure; or
  - (b) such proceedings having been taken, the action is dismissed for want of prosecution; or
  - (c) the court decides against the claimant;

the hay or timber may be confiscated, and may be turned over to the Saskatchewan Timber Board for disposition on behalf of the department or, after thirty days' notice, posted up at the place where it is when confiscated, be sold at public auction on the order of the minister.

- (3) Instead of confiscating the hay or timber, the minister may impose a penalty which, in addition to all costs incurred, shall be levied thereon; and, in default of payment of the whole, on demand, he may, on fifteen days' notice, sell the hay or timber by public auction, and may, in his discretion, retain the whole proceeds of the sale or the amount of the penalty and costs only:

Provided that, if there is no bid for hay or timber put up at public auction under this section, the minister may dispose thereof by private sale.

**Burden of proof on claimant**

**43** If hay or timber is seized for non-payment of dues or for any cause of forfeiture, or a prosecution is instituted for a penalty or forfeiture under this Act, and any question arises as to whether the dues have been paid or whether the hay or timber was cut on other than provincial lands, the burden of proving payment, or of proving on what land the hay or timber was cut, shall lie on the owner or claimant thereof.

**44** An officer seizing hay or timber in the discharge of his duty under this Act may, in the name of the Crown, call in any assistance necessary for securing and protecting the hay or timber so seized.

**Homesteader selling timber**

**45** Any holder of an entry for a homestead who, previous to the issue of the letters patent, sells any of the timber on his homestead to anyone other than a settler for his own exclusive use, without permission previously obtained from the minister, is guilty of an offence and liable on summary conviction to a fine not exceeding \$100, and the timber so sold shall be subject to seizure and confiscation in the manner hereinbefore provided.

## PART III

**Provincial Forests****Land in provincial forests not to be sold, leased, etc.**

46(1) In order to reserve certain areas in the province for a perpetual growth of timber, and to preserve the forest cover thereon, which regulates stream flow, and to provide for a reasonable use of all the resources which the forests contain, all provincial lands within the respective boundaries of the provincial forests mentioned in the schedule to this Act are hereby withdrawn from disposition, sale, settlement or occupancy, except under the authority of this Part or of regulations made thereunder.

(2) Notwithstanding anything contained in subsection (1) the Lieutenant Governor in Council may withdraw from a provincial forest any land having a historical interest or required for the purpose of subdividing the same into lots for residential or business purposes or both.

(3) Where provincial lands within the boundaries of a provincial forest have been sold prior to its establishment as a provincial forest, and the letters patent by which they were sold contain an error in the name, place of residence or occupation of the purchaser, or in the description of the lands, the minister may, there being no adverse claim, direct the defective letters patent to be cancelled and letters patent to be issued with such corrections or alterations as he may deem necessary.

(4) All statutory road allowances, surveyed roads, streets, lanes and public reserves between or within parcels of land contained in a provincial forest shall for purposes of forest administration be deemed to be part of the forest, subject to the provisions of *The Highways and Transportation Act* respecting public highways and subject to the exercise of the powers conferred on a rural municipality by *The Rural Municipality Act*, or on the Minister of Municipal Affairs by *The Local Improvement Districts Act*, with respect to the construction, repair and maintenance of roads, lanes, bridges and culverts.

**Provincial forests**

47 The lands so withdrawn shall be known as Provincial Forests for the maintenance, protection and reproduction of the timber thereon, for the conservation of the minerals and the protection of the animals, birds and fish therein, and for the maintenance of conditions favourable to a continuous water supply, but subject to any regulations made under this Part.

**Power of Lieutenant Governor in Council to acquire lands in provincial forests**

48(1) The Lieutenant Governor in Council may direct the minister on behalf of the Crown to acquire by purchase, expropriation or otherwise any land within a provincial forest, the title to which is not vested in the Crown, or to exchange therefor available provincial lands situated outside the boundaries of any provincial forest, and, where necessary, to make compensation upon such exchange, and a copy of every order in council authorizing such acquisition or exchange shall be laid before the Legislative Assembly during the first fifteen days of the next session thereof.

(2) The minister shall, for the purposes of this Act, have in addition to the powers therein enumerated all the powers conferred upon the Minister of Public Works under *The Public Works Act*; and the provisions of that Act shall apply, with the necessary changes, to proceedings under this Act, including the payment and determination of compensation for property taken under the compulsory powers herein conferred.

(3) Notwithstanding anything in this Act, the Lieutenant Governor in Council may cause to be established through and over any provincial forest such roads as are necessary for the convenience of the public, and nothing in this Act or in any regulation made hereunder shall prevent the proper use of such roads by *bona fide* travellers or by others requiring to cross such forest in pursuit of their ordinary business or calling; but nothing in this section shall operate to withdraw such roads from the provincial forest.

(4) Where he deems it expedient to do so, the minister may close up the whole or any portion of any road established under subsection (3).

**Act not to apply where Crown has no title**

**49** Except as herein provided, this Part does not apply to any lands within the boundaries of a provincial forest the title to which is not vested in the Crown; and nothing in this Part shall affect or prejudice any right or interest which has been acquired prior to the establishment of the provincial forest within which such right or interest has been acquired, under any lease or licence for cutting timber for any purpose in respect of any lands within a provincial forest:

Provided that when any land in respect of which a lease or licence to cut timber has been granted, does not contain or has become denuded of merchantable standing timber, such land may thereupon be withdrawn from such lease or licence upon notice to the lessee or licensee.

**Release of interest in land within provincial forest**

**50** The Lieutenant Governor in Council may secure, from the holder of any title to or interest in land within the limits of a provincial forest, a waiver in writing of the exemption of such land from the provisions of any regulation made under this Part for the prevention of trespass and the protection of game, and where necessary may make compensation therefor; and from the date of such waiver, and to the extent therein agreed upon, this Part and the regulations made hereunder shall apply to such lands.

**51** Neither the Lieutenant Governor in Council nor the minister shall, for the purposes of this Part, expropriate, purchase or acquire for compensation any right or interest held under a licence to cut timber.

**Arrest of offenders and seizure of property**

**52(1)** Any officer may, on view, without warrant or legal process, arrest and bring before a justice of the peace, to be dealt with according to law, or may, on view, arrest and remove from a provincial forest any person found violating any provision of this Act or *The Provincial Lands Act* or of the regulations made thereunder.

(2) Any officer may seize, whether within a provincial forest or elsewhere, all timber, trees and hay cut or removed, all mineral or other products removed, and within a provincial forest may seize all firearms, ammunition, spears, traps, nets, rods, lines, tackle and appliances used by, or found in the possession of, any person, without lawful authority, or in contravention of any provision of this Act or *The Provincial Lands Act* or of the regulations made thereunder, and may seize the outfit and all equipment used by or found in the possession of any person or persons arrested for capturing or killing any animal, bird or fish.

**Entry and search without warrant**

**53(1)** For the purpose of searching for anything mentioned in subsection (2) of section 52, any officer may, without warrant or legal process, enter and search any house, dwelling, structure or camp within a provincial forest.

(2) An arrest, removal, seizure or confiscation shall not relieve the offender from any other penalty to which he may be liable under this Act or *The Provincial Lands Act* or otherwise.

**Lands required for railway purposes**

**54** The Lieutenant Governor in Council may sell or lease lands within a provincial forest when such land is required for the right of way or station grounds of a railway, but such land, subject to the use for which it is sold or leased, shall still be part of the provincial forest within which it is situated; and if any such land ceases to be used for the purpose for which it was sold or leased it shall forthwith revert to the Crown.

**Regulations**

**55** The Lieutenant Governor in Council may make regulations for the protection, care and management of provincial forests and Crown timber on provincial lands including regulations governing:

(a) the cutting and removal and sale of timber, the right to enter upon, use and occupy such portion or portions of provincial lands in provincial forests as may be necessary for the purpose of mining, the pasturage of live stock, the use of hay lands, the establishment and use of reservoirs, water power sites, power transmission lines, telegraph and telephone lines, and the use of water rights, and any other use not inconsistent with the purposes of this Part, and the granting of leases and permits therefor;

(b) the granting of leases of lands within provincial forests, and the granting of permits authorizing the use of such lands, for agricultural, residential or business purposes for any period not exceeding thirty-three years and the disposition, by sale or otherwise, of lots shown upon a registered plan of a subdivision of land within a provincial forest, on such terms and conditions as may be set forth in the regulations;

- (c) the preservation of game, birds, fish and other animals, and the destruction of noxious, dangerous and destructive animals;
- (d) the prevention, detection and suppression of fire;
- (e) the prevention of unauthorized business and traffic;
- (f) the removal and exclusion of undesirable persons and trespassers, and of persons making unauthorized use of any forest or failing to comply with any regulations;
- (g) the confiscation and disposal of things seized;
- (h) the seizure and disposal of animals trespassing on any forest and the dues, fees and charges payable by the owner in connection with such trespass, seizure and disposal, including the costs of care and sustenance of animals seized;
- (i) all other matters necessary to carry this Part into effect according to its true meaning and intent.

## PART IV

### General Provisions

#### Interfering with notices

**56** Every person who wilfully tears, damages, defaces or pulls down any notice, poster or sign of the department, or of any of its officers, purporting to be given or posted under the law or the regulations respecting the protection of forests against fire or in connection with the sale or disposition of Crown timber or hay, is guilty of an offence and liable on summary conviction to a fine of not less than \$5 nor more than \$20.

#### Information to be given

**57** Any person using, or travelling in, a provincial forest shall, upon request, give the local field officers of the department, or other authorized officers of the Crown, information as to his name, address, routes to be followed and the location of his camps, and any other information pertaining to the protection of the forest from fire. Any person who refuses to give the required information is guilty of an offence and liable on summary conviction to a fine of not less than \$5 nor more than \$50.

#### Travel permits

**58(1)** The minister may, when he deems it necessary for the protection of a defined forest area, require that anyone wishing to enter and travel therein in any stated period shall previously obtain a permit.

(2) Such permit, called a travel permit, may be obtained without charge from the local field officer of the department or any other authorized person.

(3) No person shall travel in such defined area without having previously obtained a permit.

(4) Any person who violates subsection (3) is guilty of an offence and liable on summary conviction to a fine of not less than \$25 nor more than \$100.

#### **Officers to protect forests from fires caused by railways**

**59(1)** During the construction of any railway passing through provincial lands, the minister may appoint such officers as he deems necessary for the protection from fire of the forests along or adjacent to the railway, and every officer so appointed shall enforce the provisions of this Act and of any other Act, either of the Parliament of Canada or of the Province of Saskatchewan, and the regulations made thereunder, when and in so far as such Acts or regulations relate to the prevention of fires and are in force in the district for which the officer is appointed.

(2) One-half of the expenses incident to and connected with such fire protection shall be a debt due to the Crown from the persons constructing the railway, shall be payable upon demand of the minister, and may be recovered at the suit of the Crown in any court of competent jurisdiction.

#### **Fire rangers**

**60(1)** When a railway passing through provincial lands is being constructed or operated by a company not under the jurisdiction of the Board of Transport Commissioners for Canada, the minister may require such company to establish and maintain an efficient and competent staff of fire rangers, equipped with such appliances for fighting fire or preventing fire from spreading as the minister deems proper, and to provide such rangers with proper and suitable equipment to enable them to move from place to place along the line of railway with all due speed.

(2) The minister may require such company to maintain an efficient patrol of the line of railway and other lands in the vicinity thereof to which fires may spread, and generally, may define the duties of the company, and of the said fire rangers, in respect thereof.

(3) For the purpose of fighting and extinguishing fire, the said fire rangers may follow fires which spread from the railway to, over and upon any lands to which they may spread.

(4) The minister may require such company to make returns of the names of fire rangers in its employ who are engaged in the performance of the said duties, and of the places or areas in which they are engaged.

#### **Penalties**

**61** A person violating any provision of this Act or the regulations, for violation of which no other penalty is provided, is, in addition to any civil liability thereby incurred, liable on summary conviction to a fine not exceeding \$500 and, in default of payment of the fine and costs of prosecution, to imprisonment for any term not exceeding six months. In case of such violation by a corporation it is liable on summary conviction to a fine not exceeding \$1,000.

**Obstruction of officers**

**62(1)** A person who resists, obstructs or interferes with an officer in the performance of his duties under this Act or the regulations, or who resists, obstructs or interferes with any person aiding such officer, is guilty of an offence and liable on summary conviction to a fine of not less than \$50 nor more than \$200 and in default of payment to imprisonment for a term not exceeding six months.

(2) Subsection (1) does not apply where the act of resistance, obstruction or intereference is also an offence punishable under the *Criminal Code*.

**Oaths, etc., before whom taken**

**63** All affidavits, oaths, statutory declarations or solemn affirmations required to be taken or made under this Act or the regulations, except as herein otherwise provided, may be taken before the judge or clerk of any district court, any justice of the peace, commissioner for oaths or notary public, or any officer of the department.
