INSURANCE

6 The board shall pay producers directly for insurable deaths from the insurance fund.

7 Insurable deaths shall be paid for at a value equal to the average value of the remaining healthy animals of that class on the load.

8 The terms and conditions of the insurance policy approved by the board shall be made available to registered producers in writing upon request.

9 The terms and conditions of the insurance policy shall be binding upon all parties involved.

10 Agreement on the number, class and condition of sheep and lambs changing hands shall be indicated when the manifest is signed by the persons delivering and accepting the animals.

11 Pursuant to section 9, the onus shall be on any person disputing the accuracy of any manifest to prove that a reasonable opportunity was not given to all necessary parties to sign the manifest.

- (c) the following Electronic RFID Systems reports:
 - (a) Lambing Report to verify the tagging of lambs at birth;
 - (b) Dead Stock Report;
 - (c) Breeding Stock Replacement Report;
 - (d) Marketing Report; and
 - (e) Year-End Inventory Report.

4 The Board of Directors of the SSDB will review all applications to determine if credit for CSIP tags will be approved and issued.

The Global Transportation Hub Authority Act

GLOBAL TRANSPORTATION HUB AUTHORITY — TAXATION BYLAW

The Taxation Bylaw of the Global Transportation Hub Authority is hereby enacted as follows:

1.0 PURPOSE

The purpose of this Bylaw is to establish tax rates and impose taxes on:

- (a) all taxable property in the Global Transportation Hub sufficient to meet the estimated expenditures and transfers, having regard to estimated revenues from other sources, set out in the budget of the Global Transportation Hub Authority and the Library for 2014.

2.0 AUTHORITY

The authority for this Bylaw is:

- (a) sections 29, 30 and 31 of *The Global Transportation Hub Authority Act*;
- (b) section 26 and Division 7 of Part XI of *The Cities Act*;
- (c) sections 12, 13 and 15 of *The Cities Regulations*; and
- (d) section 22 of *The Public Libraries Act, 1996*.

3.0 MILL RATES

The Regina Property Tax Bylaw, 2009 as amended from time to time shall be imposed on all taxable assessments in the GTH.

4.0 COMING INTO FORCE

This Bylaw comes into force on the date advertised in the *The Saskatchewan Gazette*.

EMERGENCY MEASURES BYLAW

- (a) act as chairperson of the local emergency planning committee established pursuant to this Bylaw.

4.0 LOCAL EMERGENCY PLANNING COMMITTEE

There is constituted, established and continued a local emergency planning committee for the Global Transportation Hub, which shall consist of:

- (a) the local emergency measures coordinator;
- (b) the Director, Communications and Marketing; or delegate;
- (c) the Manager, Operations and Public Safety; or delegate;
- (d) a representative of Regina Fire & Protective Services;
- (e) a representative of the RCMP;
- (f) a representative of the Regina Qu'Appelle Health Region; and
- (g) any other representative of a service or tenant at the discretion of the local emergency measures coordinator.

5.0 COMING INTO FORCE

This Bylaw comes into force on the date advertised in *The Saskatchewan Gazette*.
